I understand and agree that California State Parks can file applications to register trademark(s) or service mark(s) that incorporate the artwork in connection with license plates, merchandise, promotional activities, and parks and recreational and/or educational programs. I hereby release and discharge California State Parks from any and all claims and demands arising out of or in connection with the use of the original artwork, including without limitations any and all claims for libel or invasion of privacy. California State Parks maintains the exclusive right to declare no winner if no design that meets California State Parks' needs is found. California State Parks assumes no responsibility for lost or damaged artwork. California State Parks may sell, assign, license, or otherwise transfer all rights granted to it hereunder. This release shall be binding upon me and my heirs, legal representatives, and assigns.
