DRAFT NEGATIVE DECLARATION

PROJECT: Oceano Dunes State Vehicular Recreation Area (ODSVRA) November 2009 Poker Run and Beach Clean Up, sponsored by the Friends of Oceano Dunes (FoOD).

PROJECT DESCRIPTION:

The OHMVR Division is evaluating the potential environmental effects of permitting the FoOD Poker Run and Beach Clean Up (the Poker Run) proposed for November 27 and 28, 2009.

The FoOD has applied for a special event permit to hold the annual Poker Run at ODSVRA on Friday and Saturday, November 27 and 28, 2009, just following the Thanksgiving holiday. The Poker Run comprises the following activities:

The event sponsors' pop-up shade structures and trailers would be placed in a portion of the camping area, which is already open to vehicle use, within a 150-foot by 150-foot area just south of beach marker post 4. The five Poker Run checkpoints would be located within a large flat portion of the park that is also already open to riding. Each checkpoint would comprise a small card table and a pole with a flag and be staffed by one or two volunteers. The Poker Run is a non-timed, non-race, self-guided activity during which participants visit the checkpoints where they select playing cards to gain points for poker hands. Participants can also gain points by picking up trash in the riding area. All participants would be paid camping or day use visitors, and all vehicles would be subject to the same sound restrictions and equipment requirements applicable to all SVRA visitors. All speed limit and other safety and resource-protective measures already in effect at the SVRA would apply to event participants. The event sponsor anticipates up to 100 participants on Friday November 27th and 200 participants on Saturday November 28th. All pre-existing ODSVRA camping and vehicle limits would remain in effect during the event.

FINDINGS

The OHMVR Division, having reviewed the Initial Study for the proposed project, finds that:

1. The proposed project will allow one two-day special event consisting of fundraising raffle ticket sales, Poker Run registration, off-road riding apparel and accessories vending, safety displays, and a non-race, non-timed, self-guided ride (the Poker Run), and beach clean-up.

2. All participants will be paid camping or day use visitors; all vehicles will be subject to the same sound restrictions and equipment requirements applicable to all SVRA visitors; all speed limit and other safety and resource-protective measures already in effect at the SVRA will apply to event participants; all pre-existing ODSVRA camping and vehicle limits will remain in effect during the event.
3. The project will not exceed significance thresholds for the environmental effects identified in the Initial Study Checklist.
4. A Negative Declaration will be filed as the appropriate CEQA document of the Project.

BASIS OF FINDINGS

Based on the environmental evaluation presented herein, the project will not cause significant adverse effects related to aesthetics, agricultural resources, air quality, biological resources, cultural resources, geology/soils, hazards/hazardous materials, hydrology/water quality, land use/planning, mineral resources, noise, population/housing, public services, recreation, transportation/traffic, and utilities/service systems. In addition, substantial adverse effects on humans, either direct or indirect, will not occur. The project does not affect any important examples of the major periods of California prehistory or history. Nor will the project substantially reduce the habitat of a fish or wildlife species, cause a fish or wildlife population to drop below self-sustaining levels, threaten to eliminate a plant or animal community, or substantially reduce the number or restrict the range of a rare or endangered plant or animal. The project does not have impacts that are individually limited, but cumulatively considerable.

Chapter 1 INTRODUCTION

1.1 INTRODUCTION AND REGULATORY GUIDANCE

This Initial Study/Negative Declaration (IS/ND) has been prepared by the Off-Highway Motor Vehicle Recreation (OHMVR) Division of the California Department of Parks and Recreation (CDPR). This IS evaluates the potential environmental effects of permitting the Friends of Oceano Dunes (FoOD) Poker Run and Beach Clean Up (the Poker Run), proposed for November 27 and 28, 2009.

The Poker Run comprises erection of five to seven small, temporary, pop-up shade structures within the open riding and camping area of Oceano Dunes State Vehicular Recreation Area (ODSVRA) to accommodate fundraising raffle safety displays, ticket sales, Poker Run registration, and off-road riding apparel vending the day after the Thanksgiving holiday. The Poker Run is a non-timed, non-race, self-guided activity during which participants visit five checkpoints (one card table each) within the open riding area.

The California Environmental Quality Act (CEQA; Public Resources Code § 21000 et seq.) and the CEQA Guidelines (14 CCR §15000 et seq.) establish the OHMVR Division as the lead agency. The lead agency is defined in CEQA Guidelines Section 15367 as “the public agency which has the principal responsibility for carrying out or approving a project.” The lead agency decides whether an Environmental Impact Report (EIR) or ND is required for the project and is responsible for preparing the appropriate environmental review document.

According to CEQA Guidelines Section 15070, a public agency shall prepare a proposed ND or a Mitigated ND when:

1. The IS shows that there is no substantial evidence, in light of the whole record before the agency, that the project may have a significant effect on the environment, or
2. The IS identifies potentially significant effects, but:
 - Revisions in the project plans made before a proposed Mitigated ND and IS are released for public review would avoid the effects or mitigate the effects to a point where clearly no significant effects would occur, and
 - There is no substantial evidence, in light of the whole record before the agency, that the project as revised may have a significant effect on the environment.

This IS has been prepared by the OHMVR Division of CDPR in accordance with CEQA and the CEQA Guidelines.

Chapter 2 PROPOSED PROJECT

2.1 PROJECT LOCATION AND SITE DESCRIPTION

CDPR proposes to issue a Special Event Permit for the Poker Run at ODSVRA in the community of Oceano, San Luis Obispo County, California.

ODSVRA is located in the community of Oceano, off State Route 1 (Figure 1). The SVRA, along with the access afforded via Pismo State Beach, contains 5½ miles of beach open for vehicle use, and the 1,500 acres of sand dunes available for off-highway motor vehicle recreation are attractions for visitors from throughout the United States. ODSVRA is the only California State Park where vehicles may be driven on the beach. Passenger cars can easily drive on the northern portion of the beach, while the central portion of the SVRA can be accessed with four-wheel drive vehicles and is where off-highway vehicles (OHVs) and camping are allowed. The southern portion of the park features the Oso Flaco Lake Natural Area, which is closed to vehicles.

2.2 PROJECT OBJECTIVES

The purpose of this project is to allow the FoOD-sponsored Poker Run event to occur over the Thanksgiving weekend at ODSVRA. The FoOD has identified the following objectives for the Poker Run:

- Create a sense of unity among park visitors.
- Promote beach cleanups.
- Promote responsible OHV recreation and safety.
- Fundraising for FoOD.

2.3 PROJECT DESCRIPTION

FoOD has applied for a special event permit to hold the Poker Run and Beach Clean Up event at ODSVRA during the Thanksgiving holiday period. The event would comprise the following activities:

The 150-foot by 150-foot vending/registration/staging area would be just south of beach marker post 4 in a portion of the camping area that is already open to vehicle use (Figure 2). The area would be marked by poles, flags, and snow fencing (Photo 1). The six Poker Run checkpoints would all be located within a portion of the park that is also already open to riding. Each checkpoint would comprise a small card table and a pole with a flag and be staffed by one or two volunteers. The card tables will be erected in flat sections of the open riding area for high visibility. The specific location of each card table would be determined during the event weekend, but all the card tables would be erected in the general vicinity of the Sand Highway (see Figure 2). The Poker Run is a non-timed, non-race, self-guided activity during which participants visit the checkpoints where they select playing cards to gain points for poker hands. Participants can also gain points by picking up trash in the riding area. Courtesy ATV sound testing would also be offered.

The FoOD would be responsible for picking up all garbage, markers, and event banners within 15 hours following the event. Garbage would be deposited in main dumpsters already maintained at ODSVRA.

ODSVRA operates pursuant to and in conformance with an existing Coastal Development Permit (CDP 4-82-300 and subsequent amendments) and the park's General Development Plan (CDPR 1975). All participants at the event would be paid camping or day use visitors, and all vehicles would be subject to the same sound restrictions and equipment requirements applicable to all SVRA visitors. All speed limit and other safety and resource-protective measures already in effect at the SVRA would apply to event participants. FoOD anticipates up to 100 participants on Friday November 27th and 200 participants on Saturday November 28th. All pre-existing ODSVRA camping and vehicle limits would remain in effect during the event. These daily limits (up to 2,580 street-legal vehicles, 1,000 street-legal vehicles for camping, and 1,720 OHVs) have been previously established under an approved 2001 Coastal Development Permit Amendment (CDP 4-82-300-A5). The Poker Run event would not increase the number of visitors expected to enter the park over the holiday weekend as ODSVRA already operates at the permitted overnight capacity during that weekend, and the event is not expected to draw additional large numbers of day users.

All vehicles would be subject to the same sound restrictions and equipment requirements applicable to all SVRA visitors. All speed limit and other safety and resource-protective measures already in effect at the SVRA would apply to event participants. All routine and emergency protocols would remain in place during the event. The event does not change the overall timing or nature of the motorized recreation that would typically occur in the park during the event weekend. The event does not involve a race or other timed or high-speed activity that would generate additional concerns about safety, vehicular collisions, noise, air quality, or other resource impacts. All event activities would be held in areas of the park that are normally open to motorized recreation and would not create effects beyond the areas open to motor vehicles and other recreation.

2.4 SPECIAL EVENT PERMIT CONDITIONS

CDPR has developed a standard set of special event permit terms and conditions for special events. CDPR has determined that additional conditions specific to the event are not required. The standard terms and conditions are included here as Appendix A. No other permits or approvals are required for the project.

2.5 NESTING SEASON MANAGEMENT PLAN TO AVOID TAKE OF LEAST TERNS AND SNOWY PLOVERS

Two avian species listed under the state and/or federal Endangered Species Act occur at ODSVRA. The federally-listed western snowy plover (*Charadrius alexandrinus nivosus*; threatened) and state- and federally-listed California least tern (*Sterna antillarum browni*; endangered) both breed at ODSVRA, but only western snowy plovers are present at the park by November. CDPR is in the process of developing a multi-park Habitat Conservation Plan (HCP) to permit incidental take of both species. Pending permit issuance, ODSVRA has developed and implements an extensive array of protection, monitoring, and management measures to avoid take of and support successful breeding by both species. These protocols are revisited each year, in consultation with the U.S. Fish and Wildlife Service (USFWS) and California Department of Fish and Game (CDFG), and fully implemented by ODSVRA. A subset of these measures are implemented during the non-nesting season (October 1 through February 28) to assure snowy

plovers are afforded year-round protection. Measures to be implemented during the 2009/2010 non-nesting season include:

- Weekly monitoring for the location of western snowy plovers within ODSVRA;
- Continued enforcement of dog leash laws; and
- Continued enforcement of the posted 15 MPH vehicle speed limits on the beach.

DISCUSSION

Would the proposed project:

- a. **Have a substantial adverse effect on a scenic vista?**
- b. **Substantially damage scenic resources, including, but not limited to, trees, rock outcroppings, and historic buildings within a state scenic highway?**
- c. **Substantially degrade the existing visual character or quality of the site and its surroundings?**
- d. **Create a new source of substantial light or glare which would adversely affect day or nighttime views in the area?**

No Impact. (Responses a – d) The proposed special event would take place within an area that has been subject to ongoing motorized activities, including large gatherings of vehicles, since the 1900s. The event would not result in additional street legal and off highway vehicles within the SVRA since use limits will remain in effect for the event. The event would not result in new trails or roads; all activities will take place in the Open Riding area. Only a small number of portable shade structures, display tables, card tables, and similar temporary structures would be erected over the two-day event weekend, and these items would be removed upon the conclusion of the event. The staging areas for the event would be located within a part of the park that typically has recreational vehicles and similar shade structures. The event site does not contain scenic resources such as trees, rock outcroppings, or historic buildings within view of a state scenic highway. None of the stretches of the highways located in the area (SR 1 and US 101) have State Scenic Highway Status (http://www.dot.ca.gov/hq/LandArch/scenic_highways/index.htm). SR 1 becomes a State Scenic

Highway north of the city of San Luis Obispo, about 14 miles north of the project site. The project site is not visible from the State Scenic designated portion of SR 1. Night riding is currently allowed at ODSVRA, but the event would generally not be ongoing during night hours. There will be no new sources of substantial light or glare as a result of this project. Since no new trails, roads, or any other type of development would occur, and the activities proposed are already occurring or entirely consistent with activities already occurring within the event area, no scenic vistas would be adversely affected.

DISCUSSION

Regulatory and Environmental Setting

The project is located on the San Luis Obispo County coast near the community of Oceano. The County of San Luis Obispo Air Pollution Control District (APCD) is the air quality regulatory agency for the project area. Pollution from mobile sources, such as cars, trucks, trains and marine vessels, falls outside of the Air District's jurisdiction and is regulated by state and federal agencies that establish the air pollution emission standards for vehicles and the fuel they run on. State standards for ozone and fine particulate matter (PM₁₀) are currently exceeded in San Luis Obispo County. As a result, the California Air Resources Board (CARB) has designated the county a nonattainment area for these pollutants. The California Clean Air Act requires the development of plans to achieve and maintain the state ozone standard by the earliest practicable date. The San Luis Obispo County Air Pollution Control District currently operates according to their 2001 Clean Air Plan.

The California Global Warming Solutions Act of 2006 (AB32) requires CARB to reduce greenhouse gas (GHG) emissions to 1990 levels by 2020. CARB identified 427 million metric tons of carbon dioxide equivalent (MMTCO₂e) as the total statewide GHG 1990 emissions level and adopted this level as the 2020 GHG emissions limit (CARB 2007). CARB estimates 2020 GHG emission levels will reach 600 MMTCO₂e if no actions are taken under a "business-as-usual" scenario.

The 1990 GHG inventory includes the following gases: carbon dioxide (CO₂), methane (CH₄), nitrous oxide (N₂O), sulfur hexafluoride (SF₆), hydrofluorocarbons (HFCs), and perfluorocarbons

(PFCs). Each GHG has a different capacity to trap heat in the atmosphere by absorbing infrared radiation. Almost 90% of the total GHG identified in the inventory is CO₂. The majority of 1990 emissions are tied to fuel use activities such as electrical generation, transportation, and industrial operations (CARB 2007).

CARB approved the AB 32 Climate Change Scoping Plan in December 2008, which contains the main strategies California will use to reduce GHG. Detailed strategies to implement all of the recommended measures must be in place by 2012. As stated in CARB's press release announcing approval of the Scoping Plan, key elements of the plan include:

- Developing a California cap-and-trade program that links with other Western Climate Initiative partner programs to create a regional market system;
- Strategies to enhance and expand proven cost-saving energy efficiency programs, implementation of California's clean cars standards, increases in the amount of clean and renewable energy used to power the state, and implementation of a low-carbon fuel standard that will make the fuels used in the state cleaner;
- Full deployment of the California Solar Initiative, high-speed rail, water-related energy efficiency measures and a range of regulations to reduce emissions from trucks and from ships docked in California ports;
- Measures designed to safely reduce or recover a range of very potent greenhouse gases - refrigerants and other industrial gases - that contribute to global warming at a level many times greater than carbon dioxide contributes; and
- Targeted fees to fund the state's long-term commitment to AB 32 administration.

Pursuant to Senate Bill 97 (Chapter 185, 2007) the Governor's Office of Planning and Research (OPR) is in the process of developing CEQA guidelines "for the mitigation of greenhouse gas emissions or the effects of greenhouse gas emissions." On April 13, 2009, OPR submitted to the Secretary for Natural Resources its proposed amendments to the state CEQA Guidelines for greenhouse gas emissions. These proposed CEQA Guideline amendments would provide guidance to public agencies regarding the analysis and mitigation of the effects of greenhouse gas emissions in draft CEQA documents. The Natural Resources Agency is conducting formal rulemaking in 2009, prior to certifying and adopting the amendments. Until guidelines are adopted by the Resources Agency, there are no general standards in effect to measure the significance of a project's contribution of greenhouse gas emissions to global climate change.

Discussion

No Impact. (Responses a – d) The event will not result in an additional number of vehicles, day users, campers, or OHVs at the beach beyond the established day use and camper limits. Therefore, the event does not conflict with or obstruct the implementation of the San Luis Obispo County Clean Air Plan, nor would it contribute to an air quality violation. The event does not involve new land uses and would not contribute to urban growth or introduce new sources of air emissions into the air basin, nor would it affect sensitive receptors to substantial pollutant concentrations.

The project does not involve new land uses and would not contribute to urban growth or introduce new sources of air emissions into the air basin. Exhaust from vehicle traffic during the event could result in temporary air pollutant emissions. The temporary nature of the impact is not expected to result in a cumulatively considerable net increase in PM₁₀ or ozone precursors.

The event would result in temporary emissions of GHGs (CO₂ and NO_x) from participant vehicles over the two day event period. As all vehicle quotas would remain in effect during the event, the spectator vehicles would not exceed what would be allowed without the event. Given the extremely short duration of the event, the vehicle quotas, and the park's existing status as an SVRA, the short-term increase in GHG emissions associated with the event would not impact federal or state ambient air quality standards.

The closest permanent sensitive receptors would be scattered rural residences about one mile away, which would not be affected by project activities. The event would take place in the open riding and camping area of the SVRA; camping would be allowed in designated areas.

There are no long term pollutant emissions associated with the event. Temporary emissions of OHV exhaust would occur during the event only.

e. Create objectionable odors affecting a substantial number of people?

No Impact. The activities associated with the event would not result in the creation of objectionable odors.

Regulatory Setting

In addition to CEQA, other federal and state laws apply to the biological resources identified in this report. Each of these laws is identified and discussed below.

Federal Endangered Species Act (FESA)

FESA establishes a broad public and federal interest in identifying, protecting, and providing for the recovery of threatened or endangered species. The Secretary of the Interior and the Secretary of Commerce are designated in FESA as responsible for identifying endangered and threatened species and their critical habitat, carrying out programs for the conservation of these species, and rendering opinions regarding the impact of proposed federal actions on listed

species. The USFWS and the National Marine Fisheries Service (NMFS) are charged with implementing and enforcing the ESA. USFWS has authority over terrestrial and continental aquatic species, and NMFS has authority over species that spend all or part of their life cycle at sea, such as salmonids.

Section 9 of FESA prohibits the unlawful “take” of any listed fish or wildlife species. Take, as defined by FESA, means “to harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such action.” The USFWS’s regulations define harm to mean “an act which actually kills or injures wildlife.” Such an act “may include “significant habitat modification or degradation where it actually kills or injures wildlife by significantly impairing essential behavioral patterns, including breeding, feeding or sheltering” (50 CFR § 17.3). Take can be permitted under FESA pursuant to sections 7 and 10. Section 7 provides a process for take permits for federal projects or projects subject to a federal permit, and Section 10 provides a process for incidental take permits for projects without a federal nexus. FESA does not extend the take prohibition to federally listed plants on private land, other than prohibiting the removal, damage, or destruction of such species in violation of state law.

The Migratory Bird Treaty Act of 1918 (MBTA)

Under the MBTA, it is unlawful to “pursue, hunt, take, capture or kill; attempt to take, capture or kill; possess, offer to or sell, barter, purchase, deliver or cause to be shipped, exported, imported, transported, carried or received any migratory bird, part, nest, egg or product, manufactured or not.” In short, under the MBTA it is illegal to disturb a nest that is in active use, since this could result in killing a bird or destroying an egg. The USFWS oversees implementation of the MBTA.

The Clean Water Act of 1972 (Section 404)

The United States does not have a federal, comprehensive law protecting wetlands. However, through the regulation of activities in “waters of the United States,” the Clean Water Act of 1972 is the main federal law used to protect wetlands. Section 404 of the Clean Water Act regulates the discharge of dredged or fill material into “waters of the United States,” which includes traditional navigable waters, interstate waters, certain tributaries of any of these waters, and wetlands that meet these criteria or that are adjacent to any of these waters.

The USACE also regulates activities in waters of the United States under the federal Rivers and Harbors Act. Section 10 of the Rivers and Harbors Act requires permits for any work or structures in navigable waters of the United States, including wetlands within or adjacent to these waters. Both dredging and filling are regulated activities under the Act. Navigable waters are defined as those waters that are subject to the ebb and flow of the tide, or that are presently, have been, or may be used for transport of interstate or foreign commerce.

California Endangered Species Act (CESA)

Provisions of CESA protect state-listed threatened and endangered species. The Fish and Game Commission is charged with establishing a list of endangered and threatened species. CDFG regulates activities that may result in “take” of individuals (i.e., “hunt, pursue, catch, capture, or kill, or attempt to hunt, pursue, catch, capture, or kill”). Habitat degradation or modification is not expressly included in the definition of “take” under the California Fish and Game Code, but CDFG has interpreted “take” to include the killing of a member of a species

which is the proximate result of habitat modification.

Fish and Game Code Section 1602

Section 1602 requires an entity to notify CDFG of any proposed activity that may substantially divert or obstruct the natural flow of, or substantially change or use any material from the bed, channel, or bank of, any river, stream, or lake, or deposit or dispose of debris, waste, or other material containing pavement where it may pass into any stream, river, or lake. CDFG uses the USFWS definition of wetlands when regulating these activities.

Fish and Game Code Section 3503 and 3503.5

Pursuant to Fish and Game Code section 3503, it is unlawful to “take, possess, or needlessly destroy the nest or eggs of any bird, except as otherwise provided by this code or any regulation made pursuant thereto.” Section 3503.5 provides similar protection specifically to raptors and their nests. Disturbance that causes nest abandonment and/or loss of reproductive effort is considered “taking” by CDFG.

Fish and Game Code Section 4150

Pursuant to Fish and Game Code section 4150, “[a]ll mammals occurring naturally in California which are not game mammals, fully protected mammals, or fur-bearing mammals, are nongame mammals. Nongame mammals or parts thereof may not be taken or possessed except as provided in this code or in accordance with regulations adopted by the commission.”

Environmental Setting

Four sensitive habitat types are found in and around the project site: coastal strand, active pioneer coastal dune, central coast dune scrub, and central coast foredunes. ODSVRA represents the northern extent of the Guadalupe-Nipomo Dunes system, having the plant and animal communities that are typical of the Guadalupe-Nipomo Dunes, and is therefore considered part of the larger dune system.

The Guadalupe-Nipomo Dunes is the largest remaining dune system south of San Francisco and the second largest in the state of California. It encompasses an 18-mile (29 km) stretch of coastline on the central coast of California and extends from southern San Luis Obispo County to northern Santa Barbara County. The Guadalupe-Nipomo Dunes system is home to a unique dunes ecosystem and is recognized as a National Natural Landmark. Although the project site is part of this very unique and sensitive habitat, no construction or other permanent habitat disturbance is proposed, and any disturbance would be minor, temporary, and consistent with existing uses (e.g., OHV uses and small, pop-up shade structures).

Table 1 is a table of special-status species¹, as defined by the California Department of Fish and Game (2009), with potential to occur within the vicinity of the project site. This list is based on occurrences listed with the California Natural Diversity Database (CNDDDB 2009) and field observations and local knowledge of CDPR Environmental Scientists.

Discussion

Would the proposed project:

- a. **Have a substantial adverse effect, either directly or through habitat modifications, on any species identified as a candidate, sensitive, or special status species in local or regional plans, policies, or regulations, or by the California Department of Fish and Game or U.S. Fish and Wildlife Service?**

No Impact. Sharp-shinned hawks and black rails are not expected to occur on the project site. ODSVRA contains known nesting habitat for the western snowy plover, a federally-listed threatened species, and the California least tern, a federally- and state-listed endangered species. The least tern is also fully protected under the California Fish and Game Code. The project area is not designated by the USFWS as critical habitat for either species. Both of these birds nest in dune environments, however, the event would not occur during the breeding or nesting season for either species. The snowy plover uses ODSVRA for overwintering habitat (winter season extends from November through February); least terns do not overwinter in the park and would not be present during the event (CDPR 2008c).

A program for the protection, monitoring, and management of snowy plovers and least terns is currently being implemented at ODSVRA (CDPR 2009a). The majority of the program is focused on protection, monitoring, and management measures, such as large, protected, breeding exclosures, which are implemented during the nesting season (March through September). The program also includes measures to minimize adverse impacts to western snowy plovers during the non-nesting season. These measures include:

- Weekly monitoring for the location of western snowy plovers within ODSVRA;
- Continued enforcement of dog leash laws; and
- Continued enforcement of the posted 15 MPH vehicle speed limits on the beach.

These measures would be in effect during the Poker Run event. The extensive breeding enclosure fence system is not up during the winter season.

The Poker Run event does not include any race or timed riding component. The Poker Run is a low speed event. Speed limit violations are strictly enforced within the park. As the event would not occur during the nesting season of the snowy plover and least tern and would not draw additional visitors to the park, all management protocols to avoid adverse impacts to plovers would apply to the event participants, and least terns would not be present, no significant adverse impacts would occur to plovers and terns due to the proposed special event.

Neither pond turtles, silvery legless lizards, nor coast horned lizards are expected to occur within the project area due to lack of habitat. The California red-legged frog is a federally-listed threatened species known to occur at ODSVRA. This species is restricted to the freshwater aquatic environment around Oso Flaco Lake and has been observed in upper Arroyo Grande Creek, outside of park boundaries and well away from the stream crossing, and would not be present in the areas of or affected by the special event. Brown pelicans also occur offshore and on the beach of ODSVRA. The event does not include any race or timed riding component. The Poker Run is a low speed, low impact event, would not bring additional users to the park, and thus would not be expected to affect brown pelicans.

Tidewater goby and steelhead (South-Central California Coast ESU) both occur within Arroyo Grande Creek, which must be crossed to reach the open riding and camping area, including the project staging site (Rischbieter 2009). The area of vehicle crossing is characterized as sandy beach, adjacent to the Pacific Ocean, varying in width from approximately 50 feet wide to several hundred feet wide, depending on tidal conditions. In this location, also referred to as the creek mouth, the stream conditions vary depending on the season of the year. Stream flow can vary from several thousand cubic feet per second during high flow periods in the winter and spring to no outflow to the ocean during the summer and fall, as the creek mouth is barred over until the first big rains of the season, usually in November or December. A small lagoon forms within Arroyo Grande Creek upstream from the shoreline beach crossing, providing habitat for steelhead and tidewater goby. This lagoon is completely closed to vehicles all year-round. Moreover, CDPR periodically reassesses the condition of the physical barriers that prevent vehicles from entering ponded lagoon areas regularly during the winter season. If upstream flows and tides alter the lagoon area, barriers are adjusted to prevent vehicles from entering ponded areas.

In 2008 an Instream and Riparian Activities Management Plan to avoid take of steelhead was prepared to formalize management measures related to the use of Arroyo Grande Creek (CDPR 2008a). DPR has been diligently implementing the measures described in the Management Plan. Measures undertaken at ODSVRA appear to have resulted in the overall protection of the fish populations within park boundaries, which has contributed to the overall protection of steelhead at ODSVRA. At present, DPR believes that it can continue to operate the SVRA and provide protection (attempting no take) of steelhead through the implementation of the take avoidance and management measures (these measures are included in Appendix

B). During the Thanksgiving weekend the protection and management measures would be in effect, all participants of the Poker Run would be subject to these measures, and the event would not increase the number of visitors or stream crossings. Therefore, project activities are not expected to impact the tidewater goby or steelhead.

There is a single CNDDDB record for sandy beach tiger beetle in the Oceano quad, and it is located near Oso Flaco Lake, approximately two miles to the south of the event area. There are no CNDDDB records for globose dune beetle in the Oceano quad. No specific surveys for globose dune beetle or sandy beach tiger beetle were conducted for this project as it is considered extremely unlikely that either sensitive beetle would be found in the project area. The project area is open to OHV riding and camping throughout the year and has no native dune vegetation that could support these two species or the other sensitive invertebrates. None of these species has any formal designation under either the state or federal Endangered Species Acts and none are on any candidate list maintained by either agency.

ODSVRA also supports several special-status plant species, including the state and/or federally-listed species shown in Table 1. These plants have been accurately mapped by CDPD and are protected from OHV disturbance and other recreational uses. Most of these species are located in the back dunes and near Oso Flaco Lake. In 2007 and 2008 CDPD biologists looked for known and potential La Graciosa thistle populations within the SVRA, including the riding area and vegetated islands. The plant was not found in the riding area or within vegetated islands. 2008 data from the Land Conservancy of San Luis Obispo County was reviewed for the Nipomo Mesa lupine. This species is restricted to the portion of the SVRA leased from Conoco Phillips, which is not in the riding area. None of the other sensitive plant populations are in close proximity to the project area and none would be affected by the project.

- b. Have a substantial adverse effect on any riparian habitat or other sensitive natural community identified in local or regional plans, policies, regulations or by the California Department of Fish and Game or US Fish and Wildlife Service?**
- c. Have a substantial adverse effect on federally protected wetlands as defined by Section 404 of the Clean Water Act (including, but not limited to, marsh, vernal pool, coastal, etc.) through direct removal, filling, hydrological interruption, or other means?**

No Impact. (Responses b – c) As discussed above, Arroyo Grande Creek must be crossed to reach the open riding and camping area, including the project site. Existing protocols are already in effect to protect the sensitive aquatic habitat of Arroyo Grande Creek and the lagoon from adverse impacts during vehicular crossings. Vehicle entry into the lagoon is prohibited. As the event would be subject to the Arroyo Grande Creek protection measures that are in effect at ODSVRA (refer to Appendix B), no impact to riparian or other aquatic habitat would occur due to the proposed event. The portion of the dunes within which the Poker Run would be held are already open to riding, and the event would not change the amount or nature of the use within that area. Sensitive dune vegetation is fenced off from vehicular entry. No impact to sensitive dune habitat would occur. Implementation of the project would not result in the removal, filling, hydrological interruption, or other disturbances to wetlands as no wetlands occur within the riding and camping area of the SVRA.

- d. **Interfere substantially with the movement of any native resident or migratory fish or wildlife species or with established native resident or migratory wildlife corridors, or impede the use of native wildlife nursery sites?**

No Impact. See response to a) above.

- e. **Conflict with any local policies or ordinances protecting biological resources, such as a tree preservation policy or ordinance?**

No Impact. No heritage or ordinance trees are in the project area. The project does not conflict with any local policies or ordinances protecting biological resources.

- f. **Conflict with the provisions of an adopted Habitat Conservation Plan, Natural Community Conservation Plan, or other approved local, regional, or state habitat conservation plan?**

No Impact. CDPR is currently developing an HCP that includes ODSVRA, but the HCP has not been approved by the trustee agencies. This project would be consistent with activities anticipated by the HCP.

DISCUSSION

Would the proposed project:

- a. **Cause a substantial adverse change in the significance of a historical resource as defined in §15064.5?**
- b. **Cause a substantial adverse change in the significance of an archaeological resource pursuant to §15064.5?**

No Impact (Responses a – b). The area identified for the event has been open to OHV use for many years. The event was reviewed by CDPR, and it was determined that there are no known archaeological sites within the area to be used for event activities. There are two recorded archaeological sites in the SVRA. The recorded Native American sites within the park are fully protected with hard fencing that is in place throughout the year. Trespass within the closed areas was not recorded during recent FoOD Poker Run events. Ample protections are in effect, along with ongoing monitoring, to prevent issues from arising. These sites have been successfully closed to vehicular recreation for many years. In the unlikely event that cultural resources are discovered, pursuant to standard CDPR protocols all activities surrounding the site would cease until the area has been cleared by a CDPR archaeologist.

- c. **Directly or indirectly destroy a unique paleontological resource or site or unique geologic feature?**

No Impact. The event would not significantly modify existing topography or impact paleontological resources or geologic features. There has been no documentation of unique paleontological resources or geological features in the project area by CDPR cultural resource specialists, or by other resource staff.

d. Disturb any human remains, including those interred outside of formal cemeteries?

No Impact. A cultural resource inventory performed in 2000 at ODSVRA (Gruver and Hines, 2000) did not reveal evidence of human remains. However Native American remains were located in June 2008. These remains were located more than three miles to the south of the proposed project area, well outside the open riding area of the park. The area identified for the event has been open to OHV use for many years. In the unlikely event that human remains are discovered, pursuant to standard CDPR protocols all activities surrounding the site would cease until the area has been cleared by a CDPR archaeologist and the County Coroner is notified.

DISCUSSION

Would the proposed project:

- a. **Expose people or structures to potential substantial adverse effects, including the risk of loss, injury, or death involving:**
 1. **Rupture of a known earthquake fault, as delineated on the most recent Alquist-Priolo Earthquake Fault Zoning Map issued by the State Geologist for the area or based on other substantial evidence of a known fault?**

2. **Strong seismic ground shaking?**
3. **Seismic-related ground failure, including liquefaction?**
4. **Landslides?**

No Impact. Although ODSVRA is located in a seismically active area associated with the San Andreas fault system, the proposed special event would not expose people or structures to seismic or landslide hazards. No new buildings or permanent facilities are proposed; card tables, pop-up shade structures, and other small temporary structures would not pose a hazard to park visitors during a seismic event. San Luis Obispo County hazard maps show the project area to have a low potential for landslides. Dunes are by their nature unstable and subject to movement, slippage, and blow out. Vehicular activity on active dunes can contribute to unstable soil conditions. However, the area proposed for the Poker Run is currently open to vehicular activity as part of the SVRA. No additional landslide risk would result from the operation of this event.

b. Result in substantial soil erosion or the loss of topsoil?

No Impact. The project activities would occur in sand, a highly erosive material, but typical of the area because of the beach location. The Poker Run is a non-timed, non-race event, and the area proposed for the event is currently open to vehicular activity as part of the SVRA. No additional erosion would result from this event. All event activities would be located on the sandy beach and dunes; therefore, there would be no loss of topsoil.

c. Be located on a geologic unit or soil that is unstable, or that would become unstable as a result of the project, and potentially result in on- or off-site landslide, lateral spreading, subsidence, liquefaction or collapse?

No Impact. Staging facilities for the event would be located on the flat portions of the beach. The event course would be located in the dunes, which are in constant flux due to prevailing coastal winds. The sand in the project area is subject to seasonal and daily fluctuations from wind erosion, and the event would not affect the stability of the beach or dune sheet. Sand by nature is unstable; however, no impact would occur as the small, temporary nature of the event facilities would not expose people or buildings to any risk from sand movement.

d. Be located on expansive soil, as defined in Table 18-1-B of the Uniform Building Code (1994), creating substantial risks to life or property?

No Impact. Expansive soils are not a consideration in the sandy soils found in the project area.

e. Have soils incapable of adequately supporting the use of septic tanks or alternative wastewater disposal systems where sewers are not available for the disposal of wastewater?

No Impact. The project does not propose installation of new septic tanks nor does the project create the need for a system for disposal of additional wastewater.

DISCUSSION

Would the proposed project:

- a. Create a significant hazard to the public or the environment through the routine transport, use, or disposal of hazardous materials?**

- b. **Create a significant hazard to the public or the environment through reasonably foreseeable upset and accident conditions involving the release of hazardous materials into the environment?**
- c. **Emit hazardous emissions or handle hazardous or acutely hazardous materials, substances, or hazardous waste within one-quarter mile of an existing or proposed school?**

No Impact. Gasoline and diesel needed to power vehicles and generators would be the only hazardous materials in use on the project site, and park rules require that fuel be legally contained within the vehicles or in specially designed fuel cans. In addition, the event would not increase the number of park visitors or the amount of fuel used over the event weekend. The project would not involve the routine transport, use, or disposal of other types of hazardous materials such as asbestos, lead, toxic waste, etc. The project would not involve hazardous emissions. The nearest school is over one mile from the event site.

- d. **Be located on a site which is included on a list of hazardous materials sites compiled pursuant to Government Code Section 65962.5 and, as a result, would it create a significant hazard to the public or the environment?**

No Impact. No hazardous material sites are known to occur on or in the vicinity of the project site. The project site is not on the Department of Toxic Substance Control's Hazardous Waste and Substance Site List (Cortese List).

- e. **For a project located within an airport land use plan or, where such a plan has not been adopted, within two miles of a public airport or public use airport, would the project result in a safety hazard for people residing or working in the project area?**
- f. **For a project within the vicinity of a private airstrip, would the project result in a safety hazard for people residing or working in the project area?**

No Impact. (Responses e – f) The airport closest to the project site is the Oceano County Airport located in Oceano. This airport is a general aviation airport and has an adopted Airport Land Use Plan (2007). The airport is located less than a quarter-mile east of the northern portion of Oceano Dunes SVRA, just northeast of post 1. The project site is located over one mile south of the airport (near post 4) and is not located within the Oceano County Airport land use plan area (Airport Land Use Commission 2007). The airport would not pose a safety hazard to participants of the special event. There are no private air strips within two miles of the project site.

- g. **Impair implementation of or physically interfere with an adopted emergency response plan or emergency evacuation plan?**

No Impact. The proposed special event would not impair implementation of or physically interfere with the existing ODSVRA emergency response plan or emergency evacuation plan.

DISCUSSION

Would the proposed project:

a. Violate any water quality standards or waste discharge requirements?

No Impact. The project would not create the need for additional wastewater discharge and would not cause any discharge with the potential to violate water quality standards. As discussed previously, although vehicles must cross the Arroyo Grande Creek mouth area to reach the staging area for the event, the event would not generate additional vehicles within the park or additional creek crossings as the park is expected to already be at or near capacity regardless of the event. In addition, the event would be subject to the Arroyo Grande Creek protection measures that are in effect at ODSVRA (refer to Appendix B). The project would not violate any water quality standards or waste discharge requirements.

b. Substantially deplete groundwater supplies or interfere substantially with groundwater recharge such that there would be a net deficit in aquifer volume or a lowering of the local groundwater table level (e.g., the production rate of pre-existing nearby wells would drop to a level which would not support existing land uses or planned uses for which permits have been granted)?

No Impact. The project would not extract groundwater and therefore would not affect the quantity of subsurface water supplies. The project would not change the direction or rate of groundwater flow. The project does not involve the use of groundwater supplies and therefore does not impact the groundwater table or nearby wells.

c. Substantially alter the existing drainage pattern of the site or area, including through the alteration of the course of a stream or river, in a manner which would result in substantial erosion or siltation on- or off-site?

No Impact. (Responses c – e) The existing drainage pattern of the area would not be altered as a result of the event. The project would not alter the course of a stream or river, including Arroyo Grande Creek. As discussed previously, although vehicles must cross the Arroyo Grande Creek mouth area to reach the event staging area, the event would not generate additional vehicles within the park or additional creek crossings. In addition, the event would be subject to the Arroyo Grande Creek protection measures that are in effect at the ODSVRA (refer to Appendix B). There will be no increase in the rate or amount of surface runoff, because no new impermeable surfaces would be developed for the event. The event would not create additional sources of polluted runoff.

f. Otherwise substantially degrade water quality?

No Impact. The small event would not affect water quality as it would not change the intensity or amount of use of ODSVRA over the Thanksgiving holiday.

g. Place housing within a 100-year flood hazard area as mapped on a federal Flood Hazard Boundary or Flood Insurance Rate Map or other flood hazard delineation map?

h. Place within a 100-year flood hazard area structures which would impede or redirect flood flows?

No Impact. (Responses f – i) According to the San Luis Obispo County Flood Hazard Map, the project site is located within a flood hazard area and/or a 100-year floodplain. No Impact. The project is located in an area that could be subject to inundation by tsunamis; however, the event is of very short duration and would not cause an increase in visitor use limits at the park. In the unlikely event of a tsunami, an emergency response plan is in effect for the County.

No Impact. There is no established community within the project area.

b. Less Than Significant Impact. No significant impacts would occur from the project as the event would not increase the number of visitors over a typical Thanksgiving weekend or over the daily use limits imposed at the park, nor would it change the nature of use within the park. OHV use is a legal use allowed by the park's General Development Plan (CDPR 1975) and San Luis Obispo County's Local Coastal Plan (LCP; San Luis Obispo County 2009, 2007, 1989). Some of the Poker Run activities would occur within a portion of ODSVRA currently owned by the County (commonly referred to as the La Grande Tract). The County's LCP does include a map (commonly referred to as Figure 4; San Luis Obispo County 1989) showing the County lands as a buffer area closed to OHV. When the Coastal Commission certified the County's LCP in 1984, the LCP reflected in general the conditions of ODSVRA's Coastal Development Permit 4-82-300, which allows for OHV use on the County-owned land. ODSVRA operates the County-owned land for OHV use consistent with the park's SVRA designation and in conformance with an operating agreement with the County. The special event proposed within the County-owned portion of ODSVRA would not represent a change in use of the area and would not cause a significant conflict with the LCP.

c. Conflict with any applicable habitat conservation plan or natural community conservation plan?

No Impact. The project site is not located in an area covered by an HCP or natural community conservation plan. A habitat conservation plan is being developed for certain State Park units within San Luis Obispo County, including ODSVRA; however, it has not yet been finalized.

DISCUSSION

Would the proposed project:

- a. Expose persons to or generation of noise levels in excess of standards established in the local general plan or noise ordinance, or applicable standards of other agencies?**

No Impact. The event would not result in additional street legal or off-highway vehicles within the SVRA beyond the current use limits. All sound restrictions governing OHVs would remain in place for the event. The Poker Run is not a timed race. Furthermore, Poker Run event volunteer staff will host a voluntary sound level testing station at the staging area to encourage park visitors to have their ATVs and motorcycles sound tested for compliance with sound level requirements.

- b. Exposure of persons to or generation of excessive ground borne vibration or ground borne noise levels?**

No Impact. The proposed event would not generate or expose people to excessive ground borne vibration or ground borne noise levels. Groundborne vibration or groundborne noise

levels are typically caused by blasting or pile driving. No blasting, pile driving, or similar activities would be required to erect card tables and related temporary structures.

- c. A substantial permanent increase in ambient noise levels in the project vicinity above levels existing without the project?**

No Impact. The event is temporary (one weekend) and would not generate substantial noise or create a permanent source of noise.

Less Than Significant Impact. The event is not expected to draw additional visitors into the park or increase ambient noise levels beyond levels typically experienced during the busy Thanksgiving weekend. No Impact. (Responses a – b) ODSVRA is subject to strict visitor quotas, including 1,000 camping units (a camping unit is defined as one street legal motorized vehicle registered for overnight use) per day and 2,580 street legal and 1,720 OHVs per day for day-use. The overall

vehicle limit for day use is thus limited to 4,300 vehicles (of this 60 percent street legal and 40 percent non-street legal). These visitor quotas would remain in effect during the two-day event, and due to the popularity of this holiday weekend, it is expected that ODSVRA would be filled to this quota capacity over the Thanksgiving weekend regardless of the event. Although FoOD estimates up to 200 people will participate in the event, these participants would not represent additional visitors to the park above what would normally occur over the holiday without the event. Event participants thus would not create additional backups at entrance stations.

Pier Avenue does become congested during busy summer and holiday weekends. From 2004 to 2007, the FoOD held a beach clean-up and OHV safety and noise testing event at ODSVRA each Thanksgiving holiday. The events were typically advertised solely via the FoOD website and signs within the park during the event. During this time and for several years prior, attendance records show the Park was sold out for camping on Thanksgiving weekend and included over 2,000 street-legal day use vehicles. Likewise, the park was sold out Thanksgiving weekend 2008, when no special event was held. The proposed event includes the prior activities plus the Poker Run and a few vendors. While the previous Thanksgiving events differed somewhat from the 2009 fall event, comparable visitation is expected. The same low-key advertising and addition of a Poker Run and a few vendors are not expected to draw additional visitors. Since the park camping will sell out regardless of the event, the Poker Run would not add vehicles due to overnight visitors. The event is targeted at visitors who are already planning on coming to the park, and even if the Poker Run event did attract a small number of day use vehicles to the park specifically for the event, those additional vehicles would have a negligible effect on local streets such as Pier Avenue. Any crowded traffic conditions on Pier Avenue are an existing condition during holiday weekends that would not be exacerbated by the event.

- c. Result in a change in air traffic patterns, including either an increase in traffic levels or a change in location that results in substantial safety risks?**

No Impact. The proposed special event would not affect air traffic patterns.

- d. Substantially increase hazards due to a design feature (e.g., sharp curves or dangerous intersections) or incompatible uses (e.g., farm equipment)?**

No Impact. The proposed special event is consistent with activities within an SVRA. The sponsors for the event would erect the checkpoints in open areas and erect flags for extra visibility. The speed limits in effect at ODSVRA would apply to the event participants. The Poker Run is not a race and would not create any traffic hazards.

- e. Result in inadequate emergency access?**

No Impact. The proposed special event would not affect emergency access. All entrances are required to allow emergency vehicles access at any time.

- f. Result in inadequate parking capacity?**

No Impact. The proposed special event would not affect parking capacity. See response a. regarding vehicle limits and visitation.

DISCUSSION

Would the proposed project:

No Impact. (Responses a – e) No water uses are proposed that would result in exceedance of waste water treatment requirements. Existing CXTs (vault toilet facilities) would adequately serve the event, which would not bring additional visitors into the park. The project would not require construction of new or expanded water or wastewater treatment facilities. This project consists of a two-day special event taking place at the beach and in the dunes and would not affect storm water drainage or facilities. No new water supplies or entitlements would be needed; there would be no expansion of existing water use associated with this project.

- f. **Be served by a landfill with sufficient permitted capacity to accommodate the project's solid waste disposal needs?**
- g. **Comply with federal, state, and local statutes and regulations related to solid waste?**

No Impact. (Responses f – g) The project consists of a two-day special event and would not result in new housing or businesses that would require permanent year-round garbage collection. FoOD would be responsible for picking up all garbage, markers, and event banners within 15 hours following the event. Garbage would be deposited in main dumpsters already maintained at ODSVRA, the number and capacity of which have been designed to accommodate users on a busy weekend. ODSVRA manages trash collection in compliance with all federal, state, and local laws and statutes.

DISCUSSION

As discussed above, all participants would be paid camping or day use visitors, all vehicles would be subject to the same sound restrictions and equipment requirements applicable to all SVRA visitors, all speed limit and other safety and resource-protective measures already in effect at the SVRA will apply to event participants, and all pre-existing ODSVRA camping and vehicle limits would remain in effect during the event. The proposed project would thus not substantially degrade the quality of the environment, significantly impact fish or wildlife species or their habitat, adversely affect plant or animal communities, or affect historic or other cultural resources.

Appendix A SPECIAL EVENT PERMIT TERMS AND CONDITIONS

SPECIAL EVENT PERMIT TERMS AND CONDITIONS*

Special Event Permits, when approved, shall be issued subject to the following provisions:

1. All activities and arrangements for advance preparations within the above named unit, shall be at the direction of the District Superintendent or authorized representative.
2. Rules and regulations of the Department of Parks and Recreation unless specifically exempted or otherwise noted shall be observed by the permittee, employees, agents, or contractors.
3. The only special activities granted permittee herein are those which are listed in writing on the permit.
4. No structures or sets may be constructed unless specifically provided for and described in writing, no digging or excavation is permitted, and no shrubbery or trees are to be cut, trimmed or injured. No additions, alterations, modification, or decorations may be affixed to any Department of Parks and Recreation facility without specific written approval of the District Superintendent.
5. Fires will not be permitted except upon the specific written approval of the District Superintendent and under specific direction.
6. Vehicles under the authority of the permittee will be parked in areas designated by the District Superintendent.
7. Permittee will control all traffic and vehicles associated with the event as directed by the District Superintendent.
8. Permittee will maintain the permitted area in a clean and sanitary condition and will restore the area to the condition in which it was received to the satisfaction of the State.
9. Permittee will repair or be billed at the discretion of the State any and all damage to the park unit or any State property which was a result of permittee's activities. State will be the sole judge of the extent of damage and the extent of repairs required to remedy the damage. All repairs will be performed to the satisfaction of the State.
10. The State may require at its discretion, the following special conditions:
 - a) Fire control measures and additional fire fighting equipment to be furnished by permittee as required by the District Superintendent.
 - b) First-aid service to be supplied by permittee, including ambulance service, doctors or nurses.
 - c) Additional police protection and/or traffic control personnel. Policing of the event will be provided by permittee and at own expense.
 - d) Parking arrangements required for permittee's operating personnel.
 - e) Additional sanitary facilities as required by the District Superintendent. Sanitary facilities over and above those furnished by State may be provided by permittee and at own expense.

- f) The permittee will be charged a fee based on the number of hours and job classification of State personnel required to meet any special condition.

All special conditions and associated fees will be listed on the permit.

- 11. Unless otherwise specified on the Special Event Permit, the State agrees to provide the following services, if available or appropriate.
 - a) Maintain public restrooms.
 - b) Provide fresh water.
 - c) Provide electricity.
 - d) Provide garbage cans and remove refuse.
 - e) Clean all areas prior to occupancy by permittee.
- 12. The interest of permittee created by this agreement may be subject to property taxation. Permittee agrees to pay any possessory interest tax or any other tax levied on such interest and to indemnify the State from any damage or loss arising, by reason of such tax or Revenue Taxation Code Section 107.6.
- 13. Permittee may be charged a permit fee in addition to normal park fees, based on costs incurred by the State, size and scope of the event, and prevailing fees for commercial facilities in the locality.
- 14. Depending on circumstances and probability of occurrence, permittee may be charged a damage deposit as determined by the District Superintendent. Costs for damage repair and any fines or penalties for noncompliance with permit conditions will be deducted from this deposit, The District Superintendent shall determine if all or only a portion of the deposit is refundable.
- 15. The District Superintendent may terminate without prior notice any special event activity when it is necessary for the safety and enjoyment of the public for the protection of resources, or for violation of any rules or regulations of the Department of Parks and Recreation or conditions of this permit. In addition, any Special Event Permit may be cancelled without notice in the event of disaster or unforeseen emergency.
- 16. It is an express condition of this permit that the State, its officers, agents and employees shall be free from any and all liabilities and claims for damages and/or suit for or by reason of any death of or injury or injuries to any person or persons or damages to property of any kind whatsoever, whether the person or property of permittee, its agents or employees, or third persons, from any cause or causes whatsoever while in or upon said premises or any part thereof during the term of this permit or occasioned by any occupancy or use of said premises or any activity carried on by permittee in connection therewith; and permittee hereby covenants and agrees to indemnify and to save harmless the State, its officers, agents and employees from all liabilities charges, expenses (including counsel fees) and costs on account of or by reason of any such deaths, injury, liabilities, claims, suits, or losses however occurring or damage growing out of same.
- 17. For events having greater potential hazard or liability to the State than is incurred through typical daily park activities, permittee will be required to provide the District Superintendent with a certificate of insurance with required endorsements as proof of liability insurance coverage. The policy will cover the period of the permit and will be in an amount no less than one of the following as determined by the District Superintendent:

- Public Liability \$300,000 each person, \$500,000 each occurrence. Property Damage Liability and Products Damage Liability \$200,000; OR
- Combined single limit (CSL) \$500,000 per occurrence; OR
- Combined single limit (CSL) \$1,000,000 per occurrence.

Insurance policies shall be underwritten to the satisfaction of the State and shall contain the following special endorsement:

State of California, its officers, employees, and servants are included as additional insured but only insofar as operations under this contract or permit are concerned;

The insurer will not cancel or reduce the insured's coverage during the period that this permit is in effect or without 30 days prior written notice, whichever is shorter, to State.

This cancellation provision shall not be construed in derogation of the duty of the permittee to furnish insurance during the entire term of the permit.

18. Contacts relating to the insurance policy and payment of fee and in regard to the permit generally may be made through the District Superintendent.

Measures and Protocols at ODSVRA and Pismo Dunes Natural Preserve

Immediately adjacent to a high-use area frequented by both pedestrians and many vehicles, Arroyo Grande Creek and its lagoon have historically supported a diverse assemblage of native fish as well as some predatory non-native warmwater species. However, these fisheries have been severely impacted by adjacent land uses and upstream hydrology. To help ensure that visitor use does not contribute to additional impacts to steelhead or their habitats, DPR will provide educational and interpretive signage to inform the public about potential threats to water quality and aquatic habitat and to discourage depreciative behaviors (e.g., littering, unlawful collecting) that might contribute to this degradation. Areas of stream and lagoon that harbor fish, or provide habitat likely to be occupied by steelhead, shall be closed to vehicle use. DPR shall conduct periodic fishery surveys to detect changes in population trends and distribution and to assess any threats due to habitat changes or impacts from activities in adjacent areas. Specific measures are as follows:

Arroyo Grande Creek Crossing:

Several management measures have been identified and will continue to be implemented for the purposes of providing additional protection to aquatic and riparian resources, including steelhead:

- ❑ Only street legal motor vehicles are allowed to cross Arroyo Grande Creek. Non-street legal vehicle operation is confined to the camping and riding area of ODSVRA, south of beach marker post #2, approximately ¼ mile south of Arroyo Grande Creek.
- ❑ The Arroyo Grande Creek Lagoon and areas west of the lagoon where waters have pooled are posted closed to motor vehicle access.
- ❑ Pursuant to Superintendent's Order No. OHV-554-5-07, visitors are prohibited from crossing Arroyo Grande Creek in any other manner than by crossing the creek as close to the ocean waterline as possible and parallel to the ocean waterline. Driving upstream or downstream in the creek channel or in any other manner in the creek channel is prohibited. If the creek crossing is posted "closed," crossing the creek is prohibited.
- ❑ As necessary, after major flows or other natural events that change the physical habitat characteristics of the estuary, DPR staff realign the area closed to motor vehicles to prevent vehicle access into areas that could support steelhead trout.
- ❑ Creek crossing with motor vehicles is regulated by park Visitor Services and Ranger staff daily and during periods of high stream flow and during periods of high stream flow in combination with high tides. Creek crossing may be restricted or closed at any time, depending on these conditions. Enforcement action is taken by Rangers where appropriate.

- ❑ Specific guidelines provided at the end of this Plan for closure of Arroyo Grande Creek to vehicular crossings by the public will continue to be implemented.

Public Information and Interpretation:

- ❑ All first time visitors are provided with a flyer or pamphlet describing the natural history of sensitive fish species, their status under endangered species acts, recovery efforts in place within the SVRA, and a list or description of activities either prohibited or desired by the public that serve to protect steelhead.
- ❑ Interpretive panels describing the fishery populations' status and threats to their survival will be posted at the ODSVRA Safety Center located at the entrance to Sand Highway, and at the Pier Avenue and Grand Avenue entrances ramps to the SVRA.
- ❑ 7 days a week, 24-hours a day the ODSVRA AM radio station will be utilized to broadcast visitor safety, park rules and regulations, and creek conditions, including actions that visitors can take to help assure the survival of the species.
- ❑ ODSVRA will continue and expand the volunteer coordination of the "Dune Patrol" volunteers to make them aware of fishery status and potential threats of illegal entry activities.

Enforcement Activities:

- ❑ DPR peace officers will continue to aggressively enforce trespass into the aquatic zone closures, the dog leash laws, the posted 15 MPH beach speed limit, fireworks violations, and litter violations. During periods of anticipated high visitor use, Ranger staff have increased observations and focused law enforcement functions so as to eliminate threats to fisheries (including steelhead) associated with those visitor activities.
- ❑ DPR peace officers will continue to respond to requests by monitors or other staff for assistance with aquatic zone (lagoon) protection and security. Enforcement of laws affecting the protection of lagoon resources (including steelhead) is a high non-emergency priority for law enforcement focus and action within the ODSVRA.
- ❑ During anticipated high visitor attendance periods, DPR peace officer staff provide additional enforcement focus on ensuring the integrity of the signed closure is maintained and no trespass occurs within lagoon areas.
- ❑ During daylight hours on major holiday periods, at least one (1) DPR peace officer is assigned the primary duty of patrolling the beach, including the creek crossing and signed lagoon closure area, ensuring that no entry is made into areas potentially occupied by fish (including steelhead).
