



## NOTICE OF AVAILABILITY AND INTENT TO ADOPT A PROGRAMMATIC INITIAL STUDY/NEGATIVE DECLARATION FOR THE PROPOSED HUMBOLDT REDWOODS ROAD AND TRAIL MANAGEMENT PLAN

**Date:** January 31, 2019

The California Department of Parks and Recreation (DPR) has prepared and intends to adopt a Negative Declaration for the proposed project, in compliance with the California Environmental Quality Act (CEQA) and State CEQA Guidelines. DPR is the lead agency for the proposed project under CEQA.

**PROJECT LOCATION:** Humboldt Redwoods State Park (HRSP) is located 45 miles south of Eureka, near the communities of Pepperwood, Holmes, Redcrest, Weott, Myers Flat, Miranda, and Phillippsville, adjacent to the Avenue of the Giants (Hwy 254), and the South Fork of the Eel River in southern Humboldt County, CA.

**DESCRIPTION OF THE PROPOSED PROJECT:** California Department of Parks and Recreation proposes to adopt a Road and Trail Management Plan describing the existing roads and trails of Humboldt Redwoods State Park and providing specific direction for management and operations in the future.

**PUBLIC REVIEW PERIOD:** The Programmatic Initial Study/Negative Declaration is being circulated for public review and comment for a period of 30 days, beginning January 31, 2019.
