
## Mission Statement

## What is a General Plan?

- Required by State law before development of substantial facilities.
- Serves as the primary management document for the park units.
- Describes the parks' purpose and vision.
- Provides long and short-term goals and guidelines to guide day-to-day decision making and long range management.



## What is an Environmental Impact Report?

- The California Environmental Quality Act (CEQA) requires that public agencies analyze all “reasonably foreseeable significant environmental effects” of approving a project (CEQA Guidelines Section 15152).
- Describes environment factors, including plants, animals, soils, air, water, noise, traffic and other projects occurring nearby.



## What is an Environmental Impact Report?

- Analyzes how these factors might be impacted by the proposed development or policies, and provides alternatives and mitigation measures to minimize significant impacts.
- General plan process will include a program EIR.


