Time and Tour Information: The tour is open to the public. The tour will begin at Hungry Valley SVRA, CCC Dorm (see above Latitude / Longitude) at 8:30 a.m. The tour will last approximately 7 to 8 hours and may involve some walking over uneven terrain. In order to participate in this motorized tour, you must have a side-by-side (ROV) or smaller 4x4 vehicle. Helmets are required for ROV occupants. Layered clothing, sturdy footwear, protective head gear, sunscreen, goggles, and gloves are recommended. Participants are also encouraged to bring sufficient food and water supplies for a full day on the trail.

Following the conclusion of the tour, OHMVR Commission members may leave for a recreational ride. No business will be discussed and the public is invited to attend.
