# CHINA CAMP STATE PARK PICNIC AREA INFORMATION SHEET

**PLEASE KEEP THIS SHEET FOR YOUR REFERENCE**

**PARK HOURS** at the picnic areas are from 8 AM until the **posted closing time**. These areas are locked by the patrol ranger each evening at the indicated time. Groups using the Back Ranch amphitheater must leave the parking lot by the **posted closing time** at the campground, which is 9:00 PM - the gate is locked at that time.

**PARKING** When reserving Buckeye Point or Weber Point, vehicles may be double parked at your discretion and the handicapped space may also be used by your group. Parking space is limited so carpooling is suggested. Groups using the Back Ranch Amphitheater must park in the **Day Use/EnRoute** parking lot at Back Ranch Meadows Campground.

**FIRES** are only allowed in the barbecue pits provided or in appropriate cooking devices (Coleman stoves, Weber type grills, etc.) No ground fires are permitted.

**ELECTRICITY** is **not** available at China Camp State Park. Permission is required to use a generator in the park.

**DEAD, FALLEN, AND LIVE WOOD** cannot be collected at any time in the park. Decaying wood forms soil and assists the growth of vegetation.

**DOGS AND DOMESTIC ANIMALS** are not allowed to run at large in state parks. They are allowed only in the developed portion of the picnic areas. Dogs must be on a leash **no longer than 6 feet**, with the leash tied or held at all times.

**MUSIC:** is allowed in the picnic areas but please be aware that many other visitors are using the park. In the event that your music becomes too loud, you may be asked to play it more quietly or to stop playing altogether.

**TRASH and LITTER** must be placed in the receptacles provided. **Excess garbage** that will not fit inside the receptacles must be **carried out**. Leaving the area unclean will result in the forfeiture of your security deposit.

**SECURITY DEPOSIT** Your security deposit will be mailed to you after your event provided there is no damage or clean-up to be done and your group has followed all requirements of this use permit.

**TO CANCEL YOUR RESERVATION** you must notify China Camp State Park at (415) 456-0766 at least **48 hours** in advance of your event. Failure to do so may result in the forfeiture of your security deposit.
