Unit Service Reductions

Folsom Sector

Service Reductions:

- Seasonal Closure of outlying units:
 - Rattlesnake Bar
 - November 1st to April 1st or,
 - While the lake elevation is below 426'
 - Skunk Hollow (November 1st to April 1st)
 - Salmon Falls Raft Takeout (November 1st to April 1st)
 - Nimbus Overlook (November 1st to April 1st)
 - Peninsula (October 1st to April 1st)
- Year round closure of outlying units:
 - Nimbus Shoals
 - Nimbus Dam Overlook
 - Park Shore
 - Old Salmon Falls
- Reduction in Park Hours
 - For units normally closed at 10 PM during the summer months, closure will occur at 9 PM (daily closure reduced by 1 hour).
 - For units normally closed at 9 PM during the summer months, closure will occur at 8 PM (daily closure reduced by 1 hour).
 - Park closure hours changed from 7 PM to 6 PM during winter months (daily closure reduced by one hour).

Delta Sector

Service Reductions:

- Year round closure of outlying units:
 - Windy Cove
 - Delta Meadows

- Reduction in Park Hours:
 - **November 1st – February 28th:**
 - One campground loop open Friday, Saturday, Sunday nights
 - Group campground closed
 - Day use area closed
 - Launch Ramp open 7 days a week
 - **March 1st – June 30th:**
 - Campground open Friday, Saturday, Sunday nights
 - Group campground Closed
 - Day use Closed
 - Launch ramp open 7 days a week

Closed Monday


Hours Tuesday – Sunday

Nothing herein shall be construed in derogation of other provisions of law.


