## **Hours of Operation and Seasonal Closures**

The lands and facilities of Auburn State Recreation Area are hereby closed to the use, entry, occupancy or parking of vehicles except as provided below. Daily closing hours are posted at major public use areas and entry gates. Outbound gates are closed at the posted closing hour. Inbound gates may be closed thirty (30) minutes earlier.

### **Day Use Hours:**

Day use hours for all areas in Auburn State Recreation Area are sunrise to sunset, year round.

Regular day use hours for Mammoth Bar, China Bar and Lower Lake Clementine are 8:00 a.m. to sunset.

Vehicle access to China Bar is prohibited Tuesday, Wednesday and Thursday year round with the exception of the Fourth of July when it will be open to public entry.

When seasonally open, vehicle access at Upper Lake Clementine will close at 6:30 p.m. All vehicles must exit Upper Lake Clementine by 7:00 p.m.

### **Seasonal Gate Closures:**

Upper Lake Clementine Road, Drivers Flat Road (Ruck-A-Chucky Campground access), and Sliger Mine Road (Cherokee Bar) will be closed for vehicle access on October 15<sup>th</sup>. These roads will reopen after April 15<sup>th</sup> depending on precipitation and road conditions.


### **Seasonal Campground Closures**

Ruck-a-Chucky campground is closed to camping annually October 15<sup>th</sup> and will reopen annually when Driver's Flat road is open for vehicle access.

The Lake Clementine Boat-In Campground is closed to camping seasonally October 1<sup>st</sup> to April 30<sup>th</sup>.

Exception to this order may only be granted in writing by the Gold Fields District Superintendent at 7755 Folsom-Auburn Road, Folsom, CA 95630.  
Nothing herein shall be construed in derogation of other provisions of the law.


