STATE OF CALIFORNIA DEPARTMENT OF PARKS AND RECREATION SAN DIEGO COAST DISTRICT DISTRICT SUPERINTENDENT'S POSTED ORDER No. 935-022-2012

Effective August 14, 2012

- 1. The following lands and facilities of Old Town San Diego State Historic Park, San Diego Coast District of the California Department of Parks and Recreation, are hereby subject to the following provisions:
 - A. A closure shall be in effect for all public use, entry or occupancy from 2100 hours to 0600 hours daily, and/or anytime in specific areas restricted by a fence, lock, or doors. [CCR 4326(a)] Exception:
 - 1. Persons going to/from, or present at authorized concessionaires,
 - 2. Commercial or vendor services.
 - 3. Individual(s) using the Old Town Transit Center and its parking area (Lot 'G'),
 - 4. Associated with an Approved Special Event Permit.
 - B. Consumption of alcoholic beverages is prohibited, except in authorized concessions, and/or with an approved special event permit. [CCR 4326(a)]
 - C. All vehicles must remain on the pavement, park in parking lots on the pavement and within the marked lines of individual parking spaces. [CCR 4358]
 - D. Overnight parking (2:00 am to 6:00 am) is prohibited in Lots A, B, C, D, E, F.
 - E. No person shall remove or scavenge the contents of, climb on or into, trash containers.
 - F. Feeding of wild and/or feral animals is prohibited, and includes the placement of any human or animal food into containers and/or areas for such purpose of feeding. [CCR 4305(e)] <u>Exception</u>:

Persons authorized by Dept. for purposes of controlling and/or trapping feral cat population.

- G. Operating, driving and/or using a self-propelled or motorized bicycle, quadricycle, tricycle, scooter or skateboard is prohibited. [CCR 4360] Exceptions are those individuals which have a disability requiring its use for mobility.
- 2. Other exceptions to this order may only be granted in writing by the District Superintendent, San Diego Coast District, 4477 Pacific Highway, San Diego, California, 92110.
- 3. Nothing herein shall affect any existing concession contract, private contract, or property rights.

4. Nothing herein shall be construed as derogation of any existing law, rule, or regulation.
