## NOTICE OF PUBLIC HEARING

Proposed Mason Valley Ranch Addition to Anza-Borrego Desert State Park and Proposed Tulloch/Cuyamaca Ranch Addition to Anza-Borrego Desert & Cuyamaca Rancho State Parks

The California Department of Parks and Recreation (DPR), pursuant to California Resources Code Section 5006.1, will hold a hearing on a proposal to purchase two properties in east San Diego County as additions to the State Park System. The 2,117-acre Tulloch/Cuyamaca Ranch, currently owned by The Nature Conservancy, would be an addition to Anza-Borrego Desert & Cuyamaca Rancho State Parks. The 842-acre Mason Valley Ranch, currently optioned by the Anza-Borrego Foundation from the private landowner, would be an addition to Anza-Borrego Desert State Park. Both properties would provide protection of significant wildlife habitat/corridors and cultural resources.

Two identical hearings will be held on Wednesday, August 21, 2002 - the first at 2:00 p.m. in the Anza Borrego Desert State Park Visitor Center at 200 Palm Canyon Drive in Borrego Springs and the second at 7:00 p.m. in the dining hall of the Outdoor School Camp adjacent to Cuyamaca Rancho State Park headquarters off Highway 79 nine miles north of I-8. Both hearing locations are accessible to all persons.

A map of the proposed acquisitions is posted at the Anza-Borrego Desert State Park Visitor Center and the Cuyamaca Rancho State Park Museum and headquarters. The map is also available on the DPR website at www.parks.ca.gov under *News and Announcements*.

The purpose of the hearing is to record comments from local public officials and the general public on DPR's proposed acquisition of the Tulloch/Cuyamaca and Mason Valley Ranches. DPR staff will make a background presentation and answer the public's questions before opening the podium for comments. A summary of the comments will be submitted to the Legislature.

Written comments will be accepted for the record if received no later than August 30, 2002.
