## OVERVIEW

This document is a compendium providing selected information on the classified units and major unclassified properties which are currently or have in the past been associated with the California State Park System.

The main purposes of this compendium are to provide, in a single source:

1. a record of the major milestones and achievements in unit-level land use and management planning which have been accomplished through the years by the Department,
2. a variety of other information useful to understanding the past history or current status of these units and properties, and of the evolution of unit-level land use and resource management planning in the Department; and
3. The definitive number and the specific identity of those classified units and major unclassified properties which constitute the official State Park System as of the date of this report's publication .

**As of July 1, 2002, the California State Park System consists of 273 classified units and major unclassified properties.** These are identified on Lists 1 and 2 in Chapter II, following.

Located in a pocket on the inside of this report's back cover is a map of California which shows the location of the State Park System's 273 units and properties.

Copies of this document are available for examination at the Department's district offices and in the state's seventeen depository libraries. Copies of the report and its map may be obtained from the Department's Planning Division in Sacramento. This document is available in electronic format through the Internet, on the Department's website at the following address: <http://www.parks.ca.gov>.

## **DEDICATION**

This year's edition of *Planning Milestones* is dedicated to the memory of an outstanding member of a small cadre of individuals who, many decades ago, worked to make the California State Park System the fine institution it is today -

### **EARL HANSON 1905 – 2001**

Earl Hanson died on December 21, 2001, at the age of 96. Born in Oakland, California on June 30, 1905, Hanson earned a bachelors degree from the University of California at Berkeley.

After engaging in a number of occupations, his primary career began in 1937 as the first permanent Nature Guide with the Division of Beaches and Parks. Working and promoting through a number of park units and ultimately into Sacramento headquarters, he rose over the decades to become the Chief of the Division under the administration of Governor Ronald Reagan, retiring after 30 years of service. His interest in state park matters extended beyond California's boundaries, and included substantial activity in the National Conference of State Parks.

Through his energy and character, he became the Department's "Mr. Park Ranger", mentoring generations of rangers and other park staff throughout the system. For years, he authored the thoughtful and well-respected "The Better Ranger" column in the Department's monthly newsletter, News and Views.

In his early years, Earl was a master at doing imaginative and memorable campfire programs. Throughout his long and eventful life, he loved storytelling, word play and making outrageous puns. Puns that elicited groans from his audience would spur him on to ever-higher levels of this lowest form of humor.

Men like Earl Hanson provided the direction and the strength of the State Park System as it moved purposefully from its second through its fifth decade of public service. Earl added a great deal of talent and energy to the management of the lands and facilities that provided substance for the inspiration, education and enjoyment of generations of his fellow Californians.

## CHAPTER I

### REPORT ORGANIZATION AND DEFINITIONS

This document provides information on the planning reports and documents which have been prepared for the individual classified units and the major unclassified properties that currently are (or were in the past) part of or associated with the California State Park System. These are planning materials which provide broad policy and programmatic guidance for resource management, land use, facility development, interpretation and concessions, as well as for certain operational activities relevant to the unit or property. This document does not include information on plans that deal with project construction (e.g. construction of a building or campground) or with specialized resource or visitor management plans for the unit (e.g. control of exotic plant species, recreational trail usage).

The two types of properties are considered in this report:

- *classified units* - These are properties for which a specific, legislatively-defined, classification was approved either by the California State Park and Recreation Commission or, in rare instances, assigned to the property by the California Legislature; and
- *unclassified properties* - These are lands which are or have been associated with the State Park System, but which have not been classified by the Commission as units. Most of these lands are major holdings that will eventually be classified, while a few are smaller parcels that are being held by the Department; some of these parcels can be expected to be divested at some future time.

Virtually all of the Department's planning work is applied to classified units. Relatively little planning effort is expended on properties that have not yet gained this status.

In this report, well over 500 classified units and unclassified properties have been identified and organized into nine mutually exclusive categories or groups. The units and properties which have been placed in each category appear on a separate list. The title of each category's list describes or characterizes the nature or commonality of the units and properties that appear on that list. A detailed description of each category is provided on the divider page that precedes each list or set of closely related lists.

The information regarding each category's list of units and/or properties is presented in a horizontal tabular format. The descriptive title of the category itself appears in boldface type at the top left-hand side of each page of its list. All properties on each list, the classified units and unclassified properties, appear by name in the table's left-hand column, arranged in alphabetical order. A standard set of information items relevant to each unit or property appears in the row to the right of its name. In these lists, this information is arranged in columns, the headings of which are indicated and

explained below.

At this point, it should be noted that – with two exceptions - a unit’s classification is an integral part of the unit’s name. A classification is an official designation which, in effect, characterizes the inherent nature and basic value of the unit, specifies its purpose as a unit, and suggests in general terms the sort of management it should receive. There are nine basic classifications which the Commission may give to a unit. These classifications are defined in Section 5019.50 et seq of the California Public Resources Code. These classifications, and their standard abbreviations, are:

State Beach	SB
State Historic Park	SHP
State Historical Monument	SHM
State Park	SP
State Recreation Area	SRA
State Reserve	SR
State Seashore	SS
State Vehicular Recreation Area	SVRA
Wayside Campground	WC

In addition, the Public Resources Code provides three other classifications which may be given to lands which lie entirely within the boundaries of a unit with one of the nine above-listed classifications. Such units are commonly referred to as “internal units” or “sub-units.” The intent of these three classifications is to mandate greater protection to the particularly valuable natural or cultural resources situated within their boundaries. These “sub-unit” classifications are:

Cultural Preserve	CP
Natural Preserve	NP
State Wilderness	SW

Any unit with one of the nine basic classifications may have one or more internal classified units located within its boundaries.

In addition to the above-listed twelve classifications which currently exist in state law, two other classifications were individually created by the Legislature as part of specific legislation creating two specific units. Neither unit is part of today’s State Park System:

State Historic Farm	SHF
State Urban Recreation Area	SURA

Full discussion of this set of unit classifications requires two informational notes. First, State Vehicular Recreation Areas are technically a part of the State Vehicular Recreation and Trails System (SVRATS) which, by legislation, is organizationally separate from the State Park System. Second, the State Wilderness units, in addition to being a part of the State Park System, are part of a larger California Wilderness

Preservation System, as defined in Public Resources Code Section 5093.3.

The headings and contents of the columns common to the tables created for the report's nine lists may be explained as follows:

- *Unit/Property* - the name of the classified unit or unclassified property, along with – where appropriate - its classification (abbreviated).
- *Unit/Property Number* - the unit number is the last three digits of a unique six-digit number which the Department assigns for a variety of administrative purposes to each classified unit and to most major unclassified properties soon after the acquisition of their first parcels. A handful of units and properties have numbers which have been put in parentheses; these numbers are not part of the official department system but were created so that the Access Database of Purpose Statements could accommodate these otherwise unnumbered units and properties.
- *Unit/Parent Unit* – “parent unit” is a term coined for this report and used only with List 3. It is the name of the classified unit in which the list's subunit or internal unit is located.
- *Naming and Classification* - the date on which the property was named (or renamed) and/or classified (or reclassified). The Commission or the Legislature usually takes both actions at the same time, by resolution or by legislative bill, respectively, so the indicated date almost always represents both actions. The naming and classification process is described in Chapter V of this report.

Prior to the 1950s, properties were named and given one of the two then-available classifications (SP, SHM) at or soon after the time of their acquisition. At hearings held in May, July and September of 1963, the Commission reclassified many existing units into classifications which legislation had newly made available (SB, SHP, SR, SRA), also renaming a few of them in this process. An asterisk (\*) next to any of these dates indicates that these Commission actions made no change but simply reaffirmed both the unit's then-current name and classification.

- *Resource Inventory* - this document or collection of materials was known in earlier years as the Inventory of Features. What is recorded in the table is the date of the completion of this basic inventory of the natural, cultural, aesthetic and recreational resources found in the unit or property. In earlier years, the Resource Inventory was a distinct, separate publication that may or may not have been followed by the preparation of a General Development Plan. Since the late 1960s, the Resource Inventory has been an integral part of the unit level general planning process, and is used as the basis for the plan's required Resource Element (see explanation for the “RMP/Resource Element” column, below).

Note that the Resource Inventory is not the same thing as the Resource Summary,

generalized plans for the interpretation of a unit's resources. They were intended to be approved at the division chief level. Those declarations marked with an asterisk (\*) are in draft Interpretive Prospectuses which did not receive official approval.

- ◆ DPR - *Resource Management Plans or Resource Elements*: [1972 to present] Resource Management Plans were printed as part of General Development Plans. There are some Resource Management Plans that are separate documents independent of General Development Plans, some of which have official approval and others do not. Resource Elements are specific chapters in current, post-1972 General Plan documents and, as such, are approved by the Commission.
- ◆ DPN - *Naming and Classification*: In two instances, both in January 1999, proposed declarations were included as part of the Resource Summary given to the Commission as part of the material needed to take action on a unit's naming and classification. Their transmittal to the Commission implies their approval by the Director.
- ◆ DPL – *List of the GPPC*: A list of 71 Declarations of Purpose which the staff had prepared for the system's major unclassified properties and for those classified units which had a purpose statement prepared no more recently than 1975. The General Plan Policy Committee initiated the work, which was reviewed by the Director and sent by him to the Commission at its 10/2000 meeting as an informational item.
- ◆ UNK – The sources of these statements are not known.

Two other types of purpose statements appear in this collection, as indicated below.

- SPS - "*Sense of Place*": Starting in 1992, general plans contain these lengthy and somewhat poetic statements, which describe the intrinsic and less tangible values of the unit and indicate the emotional and intellectual qualities of the experience which the visitor is intended to enjoy while visiting the unit. In some cases, these are called "Spirit of Place" statements
- SPV – "*Vision Statement*": Starting in 1999, general plans contain these statements, which provide a broad overview of what the unit should be as a result of implementing the plan, the unit as a created ideal.

Each entry in this Purpose Statement column has two parts, (1) the set of letters (shown immediately above) indicating the source of statement and (2) the date indicating the month and year when the statement was approved.

- *RMP/Resource Element* - the date of the completion of a body of resource information and resource management policy guidance for the unit. The Resource

a much briefer document which is required by the Commission as background information in preparation for its action to classify or reclassify a unit.

- *Purpose Statements* – this is phrase used to encompass four kinds of statements – Statements of Purpose, Declarations of Purpose, Sense of Place (or Spirit of Place) statements and Vision Statements. These items describe the unit’s prime values and features and indicate the department’s main objectives in their management. Over the years, these statements have appeared in a number of printed sources, and have received different levels of official approval. The information immediately below identifies the sources of these different types of purpose statements, and shows the code used in this report’s tables to identify the type and source of each individual statement. Statements with an asterisk (\*) exist only in draft form and were not approved.
  - *SP - “Statement of Purpose”* – two large sets or lists of such statements were prepared by the Department, the first dated on July 27, 1959 and the second on December 29, 1975. The second list received the approval of the chief of the then-Resource Management and Protection Division.
  - *DP - “Declaration of Purpose”* – this more common type of statement has been issued on an individual basis as a component of a variety of unit-level planning documents. Distinguishing among them as a reflection of their source, this report identifies these declarations as follows:
    - ◆ *DPM - Master Plan Review Committee*: Between 1963 and 1966, a set of individually prepared declarations was prepared by a staff committee and approved in batches by both the Director and the Commission. In a few cases, the Commission indicated in the process of giving its approval that a unit’s Declaration of Purpose should be considered its Master Plan.
    - ◆ *DPG – Master Plans, General Development Plans and General Development Plan Amendments*: Individual declarations were prepared for and published in most of such plans, which were prepared between the early 1960s and 1980. Declarations of Purpose became required by law [see PRC5002.2(b)] after 1972. Prior to 1972, these plans were approved by the Director; subsequently, starting with Doheny State Beach and San Onofre State Beach, they were approved by the Commission.
    - ◆ *DPG (also) - General Plans and General Plan Amendments*: With the new type of legislatively-mandated plan first appearing in 1978 and continuing to the present, individual declarations were prepared as part of the general planning process and approved by the Commission as a part of the general plan.
    - ◆ *DPI - Interpretive Prospectus*: These five to ten-page documents, prepared during the period from the 1970s through the late 1980s, were highly

Management Plan was published as a portion of the General Development Plan document. When this type of plan document was replaced by General Plans, the Resource Element became a separate, identifiable, mandated chapter in the plan document. After 1999, resource materials, while identifiable as such, were allowed to appear at various locations throughout the plan. In early years, in cases where substantial resource work was done but no General Plan was subsequently prepared, Resource Management Plans were published as distinct documents.

- *GDP/General Plan* - the date of the Director's or the Commission's approval of the unit's General Development Plan or the Commission's approval of the General Plan. Prior to 1972, documents called Development Plans, Master Plans or (later) General Development Plans (GDP) were prepared for individual units. These plans were relatively brief, some of the earliest ones being only a map. Such plans focused almost entirely on land use and facility development. The later GDPs were broader and more holistic in their scope, and in specific sections dealt explicitly with a variety of resource management considerations. They also contained an analysis of the plan's environmental implications.

The oldest plans, the Development Plans, being sketchy and with a content that is surely obsolete at the date of this writing, are not included in this document. The same holds true for all but one of the Master Plans (Grover Hot Spring SP). Most General Development Plans, however, are sufficiently substantive and perhaps have enough current relevance to be included in this document. They are distinguished from General Plans by the presence of an asterisk (\*) placed next to the dates of their approval. A number of the very earliest GDPs often consist of only one or more maps, and are indicated with two asterisks (\*\*).

In 1972, legislation explicitly defined the scope contents of the General Plan document which was to replace the GDP as the source of unit-level planning guidance (cf Public Resources Code Section 5002.2 et seq ). The new General Plan discusses the basic resources and values of the unit, establishes the objectives for its management, and provides policies and guidelines for achieving those objectives. The General Plan is a document that is more oriented towards resource values, broader in its scope and provides more detailed in its background information than did the General Development Plan. The General Plan is approved by the Commission.

During the next thirty years, there were a number of anomalies and inconsistencies in the preparation and publication of general plans. For a period in the 1970s, a preliminary plan approved by the Commission was not republished in a different, final format. Towards the ends of the 1990s, the plans' CEQA comments and responses were published separately from the basic plan document.

In the late 1990s, a study by a departmental General Plan Improvement Team (GPIT) concluded that the General Plan had become too lengthy and too detailed in its published documentation, its analysis and its recommendations. Within the

context of the 1972 PRC requirements, the GPIT prepared guidelines for the preparation of a new type of general plan that would be shorter and more of a vision document than a directive document. In accord with these guidelines, the new general plans would provide only very broad guidance as to the Department's intentions for the unit, so that additional plans on a range of more specific topics, each additional plan requiring CEQA review, would be needed to achieve the plan's general goals. All general plans approved during and after 1999 are of this highly general type.

While all general plans are for single units; a few plan documents contain the plans for a number of closely related (in geographic terms) units. Most general plans were prepared by the department's staff. Those few that were prepared by other agencies of government or by private contractors obtained the legislatively required approval of the Commission. More detailed information on these matters may be found in Chapter VI of this report.

It should be noted that, in the interests of economy, many of the preliminary general plans prepared from the early 1970s through the mid-1980s were not reprinted as final documents after their approval by the Commission. In these cases, the word "final" was often hand-written on the cover of the preliminary document and often an explanatory memo was inserted under the document's front cover.

As a matter of historic interest, the 1963-1966 set of Declarations of Purpose might be considered the Department's first accomplishment in the broad scale preparation of unit-level plans. When the Commission approved these brief statements, it explicitly recommended to the Director that they "be adopted as the master plans of these areas."

- *GDP and General Plan Amendments* - the date on which the Commission approved alterations to all or part of a unit's existing General Development Plan or General Plan. Dates with an asterisk (\*) are amendments to General Development Plans. Most amendments cover very limited aspects of the original plan; when major changes are required, a broadly revised or entirely new General Plan is usually prepared.

Those interested in the history and development of the unit-specific general plan (and closely related studies and reports) should read the *Finder's Guide to General Plan Documents* (January 10, 2000). This document, prepared by the Northern Service Center, contains a wealth of detailed information on such matters as the nature of the early unit plans, the various and changing levels of plan approval and the many anomalies that exist in the Department's long history of general planning.

- *Comments* - this column provides a wide range of information relevant to the history and current status of the unit or property. Included here are such subjects as relevant legislation, past changes in unit name and classification, an indication as to whether the unit's plan was prepared and published individually or as part of a group

of units and the identity of the unit's operating agency or organization in those cases where it is not operated by the department itself. In an admittedly incomplete and unsystematic way, this column attempts to capture items of relevant or interesting information that would otherwise be scattered or lost. It represents an effort to add some perspective or dimension to the unit and its relationship to the current State Park System.

## **CHAPTER II**

### **INFORMATION ON THE UNITS AND PROPERTIES; CATEGORIES AND LISTS**

This chapter contains the nine lists which are identified in the Table of Contents. Each list contains the collection of classified units and/or unclassified properties characterized by the title of the list. The divider sheet that precedes each of the four sets of lists offers additional information about those lists.

## A. THE CURRENT STATE PARK SYSTEM

The 273 classified units and major unclassified properties identified on Lists 1 and 2 together constitute the California State Park System as of July 1, 2002. In the case of most of the listed units and properties, their lands and facilities are both owned (and/or leased) and operated by the Department. In a number of cases, however, local government agencies or non-profit organizations manage the units (or certain portions thereof) under the terms of an operating agreement or a concessions contract.

### List 1 - Classified Units

These are all units which have been classified by the action of the California Park and Recreation Commission or (in very rare instances) by the California Legislature.

It should be noted that a number of officially classified units do not appear on this list because they are not among the units and properties which constitute the current State Park System. They are not part of today's system due to one of the following reasons:

- they are "internal units" (see List 3) situated within one of the system's current basic units, and to include them in the system's list of basic classified units and major unclassified properties would be a form of double-counting; or
- they were, in the past, combined with other State Park System units and have thereby lost their original identity (see List 7); or
- they have been divested by the departmental by transferring their ownership to other government jurisdictions or to another organizational entity (see List 8); or
- they were classified prior to becoming the Department's property, and were ultimately not brought into departmental ownership. (see list 9).

### List 2 - Major Unclassified Properties

These are Department-owned properties which are significant in terms of their resource values or their size. Many of these properties are not proximate to or associated with an existing classified unit. The Department anticipates that, at some future date, the Commission will officially classify them as new, individual units of the State Park System. This list also includes two properties where the Department neither owns nor leases any land. The substantial significance of each of these properties and (in most cases) their intended future classification warrant their being counted and considered as part of the current State Park System.

## B. AREAS INTERNAL TO STATE PARK SYSTEM UNITS

### List 3 - Classified "Subunits"

Three types of classified units may exist only as portions of other, larger classified units. These classifications, which provide enhanced resource protection for the areas that have been so designated, are the Cultural Preserve (CP), the Natural Preserve (NP), and the State Wilderness (SW). These three types of classified units are commonly referred to as "subunits" or "internal units."

### List 4 - Unclassified "Underwater Parks"

Within certain classified units, specific underwater areas have been acquired in fee or (far more commonly) are leased from the California State Lands Commission. Such ownership or leases give the department some additional management capability in the protection and management of the natural, cultural and recreational resources found in these underwater areas. The biotic resources located in the waters above these leased lands remain under the jurisdiction of the California Department of Fish and Game. The State Lands Commission retains rights to mineral extraction from the sea floor or lake bottom at such areas. These "underwater parks" do not have specific individual names; they are simply parts of the basic units in which they are situated.

The term "underwater parks" has long been used informally by the Department and has appeared in many official documents. It has, however, no official (legislative or administrative) basis or standing.

## C. MISCELLANEOUS DEPARTMENTAL PROPERTIES

### List 5 – Small Properties Not Associated with Units

This list contains a number of small properties which are unassociated and usually distant from existing classified units or major unclassified properties. The department's General Plan Policy Committee has determined that these properties are not appropriate or likely for future Commission classification as new, separate units. The direct management of these properties, or their management through another agency, is overseen by the appropriate departmental district office.

Since 2001, the State Park System has been evaluating and accepting a number of very small coastal access easements which had been dedicated to the California Coastal Commission as one of the conditions of its issuing permits for coastal developments on private property. It is expected that each of these small parcels will be added to the landholdings of a specific classified park unit or a major unclassified property, which are found on Lists 1 and 2 of this report. Therefore, these coastal access properties will not be a part of List 5.

### List 6 - Trail Properties Located Outside of Units

This list contains a collection of properties owned in fee, as well as a number of easements and interests in property, all combined and identified by the county in which they are located. These properties were acquired for the purpose of constructing trails outside the boundaries of State Park System units, and were never intended to be specific units of the State Park System.

One set of properties was acquired for the California Recreational Trails System, which was intended to be a 3000+ mile statewide, long-distance, rural-oriented system known as the California Riding and Hiking Trail. This program was begun in the 1940s and 1950s, but was not strongly pursued because the power of eminent domain was not available to the department for the purpose of land acquisition, and because public support for such long trails was seen as inadequate.

The other trail properties found on the list were acquired in the 1970s, in response to The California Recreational Trails Act (Public Resources Code Section 5070 *et seq*). This Act embodied an effort to provide shorter trail segments which would be close to major population centers and, in some instances, would emanate from and even connect units of the State Park System.

In addition to recording the above-mentioned changes made during the previous twelve months, nearly a hundred additions, amplifications, clarifications and corrections were made to the information contained in the nine tables and the text of this document's previous edition.

In this 7-1-02 edition of this report, the former content of Chapter VI was changed. This chapter's tables previously contained a limited amount of unit-level statistical information (e.g. year acquired, county of location, and acreage). Along with other, closely related data, this information will now be found in the Planning Division's new *Statistical Report*, a document which will be published in the autumn of 2002 and which will subsequently be updated annually and published with information current to July 1 of each year.

This publication's new Chapter VI contains a graphic summary of the department's unit-level planning activity. A multi-year chart shows the dates of the approval of plans and plan amendments, as well as of unit naming and classifications efforts, which have been accomplished over the last half-century.

Readers who can offer any additions or corrections to the information contained in this document, or any suggestions for this document's improvement, are urged to submit them to the Manager of the State Park System Planning Section of the Planning Division.

## CHAPTER IV

### HISTORY OF THIS DOCUMENT

The Beilenson legislation of 1972 (Public Resources Code Section 5002.2 *et seq*) strengthened and standardized the legal requirements for the land use and management planning that was to be undertaken for individual units of the State Park System. In this legislation, specific steps and requirements were established for the preparation of what was to be called a unit's General Plan. In order to keep track of the unit-level planning that had been accomplished by the Department before 1972, as well as that which was done subsequently in accordance with the new legal requirements, Natural Heritage Section Supervisor Frederick Meyer developed an organized record of such information for each individual unit of the State Park System.

Over time, Meyer expanded his records to include a wider variety of unit-level planning information. It was enlarged to include such matters as the dates of the unit's classification and naming, the date of the approval of a unit Declaration of Purpose, the accomplishment of any substantial resource inventory or resource management planning work, and the amendments to any of the unit-level plans. During this period, Meyer expanded these records to include information on major unclassified properties, units with names which were no longer in use, and units and properties which had been divested by the State Park System. In addition, the records began to include more "miscellaneous" information on the history and current status of many units and properties. As a result, the records contained a greater and more diverse amount of useful data regarding unit-level planning and management actions.

During the 1980s, after Meyer's retirement, Jim Woodward was instrumental in expanding and updating these records, while Beth Coppedge Walls undertook the annual task of compiling, publishing and distributing the updated information as an internal report of the Resource Protection Division. As General Planning Coordinator from 1988 through 1993, Wayne Woodroof updated and added to the information base of what by what then became known informally as the "WWW Report", the Woodward – Walls – Woodroof Report. The last report in this series was dated July 15, 1993.

Following its establishment in 1993, the department's General Plan Policy Committee (GPPC) assumed the responsibility for updating and producing the WWW Report. In the process of doing this, Bruce Kennedy revised and greatly expanded the single-list format of the earlier report, so that the more than 500 classified units, unclassified properties and projects were divided into nine sets of mutually exclusive categories. A great deal of new information about the units and properties was added to the report. The first edition of this new report, entitled *Park Units and Properties Associated with the California State Park System*, was dated October, 1995.

In the next year's edition, dated July 1, 1996, a large map of California, showing the State Park System, was included in a pocket inside the document's back cover. This map identified the State Park System's districts and showed the names and locations of the system's classified units and subunits, and of the major unclassified properties located within each district. In 1999, the report was given a new title, *Planning Milestones for the Park Units and Major Unclassified Properties Associated with the California State Park System*. In early 2001, the responsibility for the annual updating and publication of this report and its accompanying map was given to the department's Planning Division.

Shortly after the beginning of each fiscal year, the Planning Division will issue a revised edition of *Planning Milestones*, containing changes which occurred during the previous year, and including any corrected or newly discovered information that is relevant to the document's contents. Each edition will, as a central purpose, specify the exact set of classified units and unclassified properties that collectively constitutes the State Park System as of the report's July 1 publication date. This is the department's official number in this matter. Some 450 copies of each edition will be printed and distributed widely throughout the Department.

The library of the Planning Division contains Department's the most complete set of the annual *Planning Milestones* publications. The current year's edition can also be found on the department's Internet homepage.

## CHAPTER V

### AVAILABILITY AND LOCATION OF ORIGINAL PLANNING MATERIALS

The central purpose of this report is to provide information on the existence of a variety of basic types of unit-level land use and management planning materials, and on the approval dates of these materials. These basic types are:

- Unit Names, Classifications and Numbers;
- Resource Inventories, Resource Elements, Resource Management Plans;
- Purpose Statements (Statements of Purpose, Declarations of Purpose, Vision Statements, Spirit of Place [or Sense of Place] Statements);
- Master Plans, General Development Plans, General Plans;
- General Development Plan Amendments, General Plan Amendments;
- Miscellaneous information on the background and/or current status of a unit or property; and

Copies of the actual materials themselves, and the records of their approval, may be found in a number of departmental or state depositories, as indicated below. All of these materials exist as hard-copy (paper). Unfortunately, none of the department's and the state's official document depositories provides an absolutely complete collection of all materials, so that some searching may be needed to find the desired item.

Certain of the above-mentioned planning materials also exist in electronic format. For specifics, see the section "Location of Electronic Documents", below.

#### Description of Materials, by Type:

The six different types of material, identified above, may be described or characterized as follows. (See also the relevant explanatory materials presented in the text of Chapter I, above.)

- *Naming and Classification Materials:* These materials consists of three items - a Resource Summary for the unit, a letter from the director to the Commission suggesting a small number of suitable candidate name(s) and classification(s) that would be appropriate for the unit, and a Commission resolution which approves the single name and classification which it has selected.

Naming and classification materials may be found in the department's Central Records and in the files of the Special Assistant to the State Park and Recreation Commission. Since 1995, these three items have been collected as a package; a small and informal document created for each unit that has been named and classified. These documents may be found in the

Commission's records, the Central Records Unit and the collections of Park Design and Construction Division.

- *Resource Inventories, Resource Elements, Resource Management Plans:* Resource Inventories are internal documents containing substantive information on a unit's resources, information gathered by the planning staff prior to preparing a General Management Plan or General Plan. These materials are far more detailed than the Resource Summary documents prepared for the naming and classification process (see above). Resource Elements are sections or chapters within the unit's published General Management Plan or General Plan.

Resource Management Plans from the 1980s are unit-wide plans developed independent of (usually prior to) a General Management Plan or a General Plan. Some of these plans have official approval, while others do not. These are not to be confused with more contemporary Resource Management Plans, which usually address a single resource management issue for a unit (e.g. fire management, trail usage) and are often prepared subsequent to a new General Plan. These more limited Resource Management Plans are not identified in this document.

Resource Inventories and Resource Management Plans may as documents be found in one or more of the Department's depositories. Resource Elements may be found in the published as a distinct chapter in General Plan documents.

- *Purpose Statements:* These are usually brief statements, most of which are only two short paragraphs in length. In general, a first paragraph summarizes the main features and values which were the purpose for acquiring the property for inclusion in the State Park System. A second paragraph indicates the nature of the Department's intended management of the unit. There are four major types of "purpose statements": Statements of Purpose, Declarations of Purpose, Sense of Place (or Spirit of Place) statements, and Vision Statements. These purpose statements are found in various sources: collections of them exist in staff-prepared lists (7/1959, 12/1975, 10/2000), and they appear individually in park-specific Interpretive Prospectuses, General Development Plans and in General Plans.

Many units may have more than one purpose statement, each prepared at a different point in time and appearing in a different source document. Regarding the many statements that a single unit may have, some will be unique in their text, while others may simply repeat ones that had been created earlier for the unit. The Department's Planning Policy and Programming Committee has determined that the most recent statement is considered the operative purpose statement for the unit.

In May of 2000, a set of 23 hardcopy reports (xerox and stapled) were created, each containing the extant purpose statements of the units and properties located in one of the (non-OHMVR) districts of the then-current State Park System. Each district office was sent a copy of the report for its own units and properties. Each regional service center was sent a copy of the reports for all of the districts which it served. A copy of all 23 district reports was sent to the Park Acquisition and Development Division and to the Central Records Unit.

In July, 2002, a loose-leaf binder of 428 pages was published, with the text of the entire purpose statement database of more than 900 items, including statements for units and properties which had been divested from the State Park System and for those which had changed in their identity. It also included purpose statements for classified subunits, those units located wholly within other classified units. This collection was assembled by unit or property, each presented in strict alphabetical order, and it includes the purpose statements for OHV units. A copy of this binder was sent to the Acquisition and Development Division, the Planning Division and the Central Records Unit.

- *Master Plans, General Development Plans, General Plans:* These items exist as maps (most Master Plans, early GDPs) and as published documents (most GDPs, all GPs). Some Master Plans consist only of a map indicating the development proposed for the unit. Master Plans and early General Development Plans were approved by the Director. Later General Development Plans and all General Plans were approved by the Commission.

In a few instances, from the early 1970s through the mid-1980s, the preliminary draft of a general plan document – after its approval by the Commission – was not republished in final form (in the interests of economy) and thus itself serves as the final plan document. This fact is usually – but not always - indicated by a letter and a copy of the Commission resolution inserted into the front of the draft document.

In recent years, there has been no consistent approach to the treatment of the Department's responses to the public comments on preliminary General Plans, comments made in the course of the CEQA public review process and made available to the Commission prior to its hearing on the plan (or plan amendment). During the 1980s and early 1990s, some published (approved) plans contained these materials as an appendix, while others did not. Following a policy initiated 1999 by the Department's Planning Policy and Programming Committee, such materials are now informally "published" separately from the plan itself, as xeroxed materials in a brown ACCO binder, and placed on the shelf next to the published general plan document. These CEQA-oriented documents are issued only in very limited quantities and are placed only in the Department's own depositories.

- *General Development Plan Amendments; General Plan Amendments:* These items exist as published documents. They range in scale from major revisions of many dozen pages to minor amendments which are covered in a very few pages. Most amendments are minor in scope, addressing only a small area of the unit or a single management topic. These amendments may be found in the same depositories as the general plan documents.
- *Miscellaneous Information:* The purpose of this publication's tables' "Comments" column is to provide salient items of information on the history, background and/or current status of the unit or property. This information is intended to give some enlarged perspective to the subject unit or property, something beyond that provided by the information found in the tables' other standard columns.

The information found in the "Comments" column have been gleaned from a wide range of sources, a few of which are no longer easily traced. These sources include Commission minutes, various studies, reports and memos, and personal conversations with many current and past employees.

#### Location of Original (Hard Copy) Documents:

The materials described above may be sought in the depositories of this department and of other state agencies. Since no depository is complete, more than one may have to be visited before finding the needed material.

#### Department of Parks and Recreation:

The department itself has three major depositories for the types of materials referred to in this report.

- *Central Records* – This depository contains a copy of most of the Department's general plan-type materials. In addition, it contains the masters for the more recent general plans and general plan amendments, making easy the reprinting of good new copies when demand warrants them. Central Records also contains the very important minutes of past Commission meetings and the bulk of past memorandums and correspondence on a wide range of relevant subjects.
- *Acquisition and Development Division* – This depository contains what is perhaps the Department's most complete and certainly the best-referenced collection of plans, plan amendments, resource studies and interpretive prospectuses. The division's collection was augmented by the even more extensive materials from the Northern Service Center, which was physically relocated and placed near the Division in April 2001

- *Natural Resources Division* – This depository has many specialized, unpublished, and hard-to-find natural resource studies and documents, in addition to a selection of the more readily available plan documents.

Some materials of interest may be found in the office of the Assistant Secretary to the Park and Recreation Commission, the Southern Service Center, and the State Park System Planning Section of the Planning Division.

#### State Depository Libraries:

Those departmental planning materials which are official published public documents may be found in the state's designated 17 official depository libraries, which are located in different institutions in various cities throughout the state. A list of these libraries may be obtained from the State Library in Sacramento. The materials in all of the state's depository libraries may be accessed through its central computerized catalog system.

#### Guidance to Original (Hard Copy) Documents

The most detailed listing and analysis of the department's more than half-century of general planning work may be found in Jim Woodward's *Finder's Guide to General Plan Documents*, dated January 10, 2000. This exhaustively researched document explores the many types of general plan-type efforts, from early drawings, to plan reports, plan amendments and plans not included in that guide. Much of the *Finder's Guide's* information on the very earliest planning efforts, as well on failed or aborted plans, far exceed the level of detail found in this *Planning Milestone* publication.

This guide discusses the level of approval granted to plans at different times, as well as differences in plan document formatting, printing, attachments and distribution. It lists cases where nearby units were planned and published in groups of two or more (see Chapter VII of this document). It provides a lengthy glossary of terms used in the department's planning work and contains a section on general notes and comments. Finally, it contains a nine-page table listing the planning documents in the department's possession, along with the date(s) of the Commission hearing and publication date, and the name of the project manager, where known.

A loose-leaf binder containing this *Finder's Guide* may be found in the libraries of the Planning Division, the Acquisition and Development Division and of the Central Records Section.

### Location of Electronic Documents:

A portion of the documents from which the information in this report is drawn is available in electronic form, and a portion of that may be accessed over the Internet through the department's website.

The more than 900 purpose statements have been entered into an Access database, which is housed at the State Park System Planning Section of the Planning Division. A compact disk (CD) holding this database may be found, along with explanatory materials, in a loose-leaf binder in the libraries of the Planning Division, the Acquisition and Development Division, and the Central Records Section. Upon request, the State Park System Planning Section can provide the statements for individual units, or the entire collection of statements, in hard copy form.

Approximately 125 of the most recent general plans and general plan amendments have been electronically scanned and are available on a set of three compact disks (CDs). These CDs may be found in a loose-leaf binder, in the libraries of the Planning Division, the Acquisition and Development Division and the Central Records Section.

This document itself, *Major Milestones for the Park Units and Major Properties of the California State Park System*, is available through the Internet on the State Parks website. As is the case with the published version, the digital version will be updated once a year, with each new edition – current to July 1 – usually being available in late August or early September. The Planning Division library contains a loose-leaf binder containing the current edition in electronic format, with instructions for revising it in preparation for the next year's edition.

All of the materials available on the Internet are on a read-only basis and may not be altered by the reader.

Over time, more of the planning information cited in this report will be made available electronically and on line. The reader should explore the department's website to see what is currently available. This department's basic Internet link is <http://www.parks.ca.gov>.

### Availability of Original or Reproduced Documents:

Copies of the more recent general plans are often available from the office of the District in which the subject park is located. The price of such documents, if a charge is made, is shown inside of its back cover.

Older plan documents and other materials for which extra copies are no longer available, may be specially copied (by xerox) by the department in order to fulfill a specific request. The recipient will be charged at the current departmental rate for this service. Government agencies are not charged for these materials.

## CHAPTER VI

### A GRAPHIC HISTORY OF GENERAL PLANNING ACTIVITY

As shown by this document's detailed lists, especially List 1, the department has been engaging for almost half a century in the work of preparing plans for the protection, development and management of the individual units of the State Park System. The different planning products – the purpose statements, the specialized studies and the plan documents themselves – contain the substance of these planning efforts.

The multi-page table and the single-page chart found in this chapter graphically summarize the annual production of this planning work in terms of three major types of planning efforts:

- Unit-level plans
  1. Master plans and general development plans
  2. General plans
- Amendments to unit-level general plans
- Naming and classification of units, and revisions thereto

The noticeable ebb and flow of unit-level planning work over the years largely reflects the availability of the funding and staff resources available to do such work. The choice of which units received planning attention at any given time reflects the contemporary sense of departmental priorities, of which plans were needed to provide guidance in the management of the unit's resources or its visitors, and/or to provide the basis which would allow for the development of desired facilities.

In reading this table and the chart, the following should be noted:

- The units listed each of the table's cells are arranged alphabetically rather than chronologically (i.e. in the order of the month of documents' approval or of the action taken);
- The units are identified by their current names and classification, which in a few cases differ from the earlier names and classification which were in place when the planning work was done and approved;
- The table and the graph contains only units that are currently part of the State Park System, as of 7-1-02; any planning that was accomplished for units and properties with names that have been lost through their combination with another unit or through divestiture from the system (see this document's Lists 7-9) are omitted;
- The planning work that was accomplished prior to 1970 has been summarized into two time periods, "before 1965" and 1965-1969. This

- was done to save space on the chart and because many of these early planning efforts are so old as to be considered non-viable;
- Units in the table's General Plans row which are *italicized* indicate that the general plan listed there has replaced an existing plan for the unit and is not the unit's first general plan;
  - Units in the table's Plan Amendments row which are *italicized* indicate that the amendment listed there is the second or third amendment (not the first) for that unit's plan
  - Units in the table's Naming and Classification row which are *italicized* indicate that the action was for a renaming and/or a reclassification action; and
  - The last year covered in the table and the graph, calendar year 2002, is only half over at the time of the date of this publication, which is July 1, 2002; additional planning activity may be anticipated during the last six months of this calendar year.



## CHAPTER VII

### MISCELLANEOUS INFORMATION REGARDING GENERAL PLANS

As an aid in researching or understanding the department's general planning efforts, it may be useful to have additional information on the publication of multi-unit plans, on plans authored by nondepartmental entities, and about certain irregularities in the numbering of park units. The following three sections will provide such information.

## A. MULTI-UNIT GENERAL PLAN DOCUMENTS

Most general plans are published as single documents that deal with a single unit of the State Park System. There are exceptions, however, where the plans for two or more units are published in one document. As a less common exception, there have been instances where a group of units are covered in a set of documents, often with an extra document in the set containing material common to all of the individual units collectively.

Following is a list of general plan documents containing plans for two different units:

- Pismo SB and Pismo Dunes SVRA (Nov 1974)
- Bothe-Napa Valley SHP and Bale Grist Mill SHP (Nov 1976)

### C. UNIT NUMBERS USED BY TWO UNITS OR PROPERTIES

For purposes of accounting and identification, the department assigns a unique three-digit number to each classified unit and major unclassified property. This system has not been used perfectly, and in a few instances two names can be associated with the same number. This has happened in two types of situations.

#### 1. Renaming a Unit

An existing unit or property is renamed and the number is carried from the first name to the new name.

## INDEX

### FOR LISTS 1 THROUGH 9

Listed below are the names of those state-owned or leased properties that are today or in some way been historically associated with the California State Park System. Some names appeared just once in the nine lists, while others may be found in many places for a variety of reasons. This index allows the reader to quickly find every appearance of any given name.

At the core of this index are the names of the 273 classified units and major unclassified properties currently in the State Park System. The index goes beyond this basic set of entries to include cross-references to “internal” units (or subunits), to the different names which some properties had in the past, and includes the names of a large number of projects, portions of parks, and key features which were important in the system’s evolving history. Many of these latter citations appear in the nine tables’ “comments” column, where they could not be quickly found without an index.

All properties listed in the index are or were owned or leased by the state; the tables’ references to properties owned by federal agencies, local government entities or private non-profit organizations are omitted.

The page numbers of the index entries are printed in one of four typeface variants - standard, standard underlined, **boldface**, and *italics*:

- The standard typeface (12-point Aerial) is used for the numbers of the pages on which can be found the unit and property names located in the left-hand column of Lists 1 through 3 and 5 through 9;
- The standard typeface, when underlined, is used for the numbers of the pages on which can be found those units in List 1 in which there is an “underwater park” area, as identified in List 4;
- **The boldface** typeface is used for the numbers of the pages on which can be found the “Parent Unit Names” in List 3, these being the units in which are situated the subunits (or “internal” units) recorded in that list; and
- The *Italics* typeface is used for the numbers of the pages on which appear the names of park areas, features and other features, all of which appear for historical or explanatory reasons in the “comments” column of the report’s nine lists.

The names of these items taken from the nine lists’ “comments” column may be variants on the property’s most commonly used name, important name changes, combinations of named properties, identifiable named areas within the basic property, or even useful geographic or physical features associated with the property. All of these referenced items are state-owned or managed.

Areas and properties in this column which are owned the federal government, local government, or by the private or non-profit sector have not been included in this index.

Unfortunately, the only method of locating the specific subject of an italicized entry is to scan the entire "comments" column of the identified page.

Note that this index does not contain entries for those situations where a unit has only changed in its classification or has had a change in name that is so minor that it cannot be easily determined by the reader.
