PROJECT TITLE: "Mt. Tam Jam" Fundraising Event

LOCATION: Mt. Tamalpais State Park

COUNTY: Marin

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Conduct an amplified music fundraising event, the "Mount Tam Jam", on June 22, 2013 in the Mountain Amphitheater at Mount Tamalpais State Park to raise funds for Mt. Tam. The event will not exceed Fire Marshall Capacity and all facilities for the event will be temporary and require no ground disturbance. Work will:

- Locate an information booth leading into the event at the entrance to Mountain Theater near Pump House for environmental and conservation organization booths;
- Place approximately 30 Portable Restrooms (4 ADA) and approximately 4 self-contained hand washing stations in the flat area between CCC Stone Bathrooms;
- Place food and drink vendor booths, a mobile food trailer (subject to County Health and ABC laws), seat rental booth and merchandise sales area booth in the traditional Mountain Play event vendor area;
- Erect portable shade structures in the upper seating area of the theater;
- Erect the stage to sit on the ground 1-2 days prior to each event and removed on the day after the event;
- Provide restrooms, dressing rooms and eating area for performers in the area between stage and stone CCC restroom/kitchen (Stage left);
- Place tables, chairs and canopies in the paved area in front of stone CCC building for a backstage area for artists.
