**PROJECT TITLE:** Place Cabin on Trailer Pad

**LOCATION:** Olompali State Historic Park      **COUNTY:** Marin

**DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT:** Place a Cavco® Cabin on an existing trailer pad site in the residence area of Olompali State Historic Park to provide staff housing. All work will occur within the existing road base surface of the pad and ground disturbance will be limited to construction of an accessible ramp and installation of rebar to secure the cabin to the surface of the pad. Existing water, electrical, and sewer hook-ups will be used. Cabin dimensions are approximately 33 feet in length, 12 feet in width, and 15 feet in height.
