(2) PUBLIC COMMENT

- (a) Public comment for agenda items: The Chairperson will entertain public comment as the Commission takes up agenda items. Individuals attending via Zoom wishing to comment on agenda items should use the "raise hand" feature in Zoom. Individuals attending in person should complete the green Public Comment – Agenda Items form and submit it to the Commission's recording secretary. Generally, comments will be limited to three (3) minutes. However, depending on the amount of comments, the Chairperson, in their sole discretion may raise or reduce the time for comments.
- (b) Public comment period for items not on the agenda: Individuals attending via Zoom wishing to address the Commission on items not on the agenda during the public comment period should use the "raise hand" feature in Zoom. Individuals attending in person should complete the green Public Comment – Agenda Items form and submit it to the Commission's recording secretary. Generally, comments will be limited to three (3) minutes. However, depending on the amount of comments, the Chairperson, in their sole discretion may raise or reduce the time for comments.
