**Classification and Naming of the New State Park (Wildwood Canyon Park Property) as Wildwood Canyon State Park**

**WHEREAS**, the units of the State Park System are classified by the State Park and Recreation Commission into categories specified in California Public Resource Code Section 5019.50; and

**WHEREAS**, Public Resources Code Section 5019.53 provides for a “state park” classification for “relatively spacious areas of outstanding scenic or natural character, oftentimes also containing significant historical, archaeological, ecological, geological or other similar values,” and that state park units shall be managed as a composite whole in order to restore, protect, and maintain its native environmental complexes to the extent compatible with the primary purpose for which the park was established, and for the purpose of making the areas available for public enjoyment and education in a manner consistent with the preservation of natural, scenic, cultural and ecological values; and

**WHEREAS**, the new State Park qualifies to be designated as a state park; and

**WHEREAS**, the new State Park will consist of one unclassified property known as Wildwood Canyon Park Property and will be classified as a state park of 855 acres for outstanding and diverse scenic, biological and cultural resources, and wide variety of recreational and educational opportunities; and

**WHEREAS**, the Commission Statements of Policy, Policy II.2, Classification and Naming Units, Features, Groves, and Trails of the State Park System outlines guidance used to identify, classify, and name units of the State Park System; and

**WHEREAS**, the Department requested and received public and tribal input for names throughout the planning process; and

**WHEREAS**, the Department considered no alternative names as the name Wildwood Canyon best supports the broad geographical setting, the properties outstanding and diverse scenic, natural, cultural, and geologic resources, and its wide variety of recreational and educational opportunities. The property is currently known as Wildwood Canyon to the public and the proposed name reflects that;



**NOW, THEREFORE BE IT RESOLVED:** The California State Park and Recreation Commission hereby approves the Director's recommendation for Wildwood Canyon Park Property to be classified as a state park; and

**NOW, THEREFORE BE IT RESOLVED:** The California State Park and Recreation Commission hereby approves the Director's recommendation for the Wildwood Canyon Park Property to be named Wildwood Canyon State Park; and be it
