SUBJECT: State Park and Recreation Commission Concurrence with Recommended Appointment to California Citrus State Historic Park Non-Profit Corporate Management Board

INTRODUCTION

The California Department of Parks and Recreation (State Parks) requests the State Park and Recreation Commission (Commission) to concur with the appointment made by the Director of State Parks to the California Citrus State Historic Park Non-Profit Management Corporation Board of Directors. (Operating agreement with the Non-Profit Management Corporation). (Commission Policy I.4)

DESCRIPTION

The California Citrus State Historic Park Non-Profit Management Corporation Board of Directors (NPMC) had two members leave the Board. Ron Loveridge concluded his term and Joyce Jong resigned. The Inland Empire District (District) and the NPMC Board have advanced a nomination for consideration.

The nomination has recommendations from the District and the NPMC Board and has been approved by State Parks Director Armando Quintero. The NPMC Board needs additional members to continue to support the management of the California Citrus State Historic Park as outlined in the Operating Agreement.
