

WELCOME! Samuel P. Taylor State Park's landscape ranges from shady canyon groves to oak-studded grasslands to the rolling hills atop Barnabe Peak. Nestled in the wooded countryside of West Marin County, the 2,882-acre park invites visitors to camp, bike, ride horses and savor a piece of paradise.

The redwood forest community enjoys a mild climate varying from dense fog and rain to full sun. Summer temperatures average in the low 80s, while winter days drop to the low 50s with frequent rainfall.

Picnic—The Azalea Day-Use Area sits in a shady grove along Lagunitas Creek. Each site has a table and barbecue. Piped drinking water and restrooms are nearby. Group picnic areas are reservable.

Hike—A wide network of fire roads and hiking, nature and equestrian trails wind through the park.

Bike—Allowed only on paved roads and multi-use trails. Bicycle riders under age 18 must wear a helmet.

Campsites—To reserve a cabin, campsite or group picnic site, visit **ReserveCalifornia.com** or call 1-800-444-7275.

Over 50 campsites with restrooms, hot showers (token-only) and piped drinking water. No spaces have hookups. Trailer max length 27 feet; RV max length 31 feet.

Cabins available with electricity, platform bunk beds (mattress not provided), wood floor, covered porch and a small electric heater. Reservations are required.

PLEASE REMEMBER

Speed Limit—The maximum speed limit is 15 mph. When pedestrians, bicyclists and children are present, even 15 mph might be too fast.

Dogs—Dogs must be on maximum 6-foot leash at ALL times and physically under control. They are allowed only in the picnic area, on the Cross Marin Trail/bike path or in your campsite. Dogs are not permitted on any other park trails or fire roads, in the creek, or any undeveloped area. Please clean up after your pets.

Plants/Wildlife—Hammocks are **prohibited**. All plants and trees are protected. Poison oak is found in most of the park. Beware of ticks and yellowjackets.

Wild animals explore campgrounds looking for food. Please store all food in provided lockers or in your vehicle.

Creek Access—Creek access is closed from Dec. 1-June 15 each year. Coho and steelhead are endangered species. Fishing is no longer permitted in Lagunitas Creek or within the park.
