**Park Hours**  
Sierra District

The following are the specified hours of closure for day use areas within Sierra District, California State Parks. The areas listed below are closed to public use, entry or occupancy within the specified hours.

1. **Emerald Bay SP, D.L. Bliss SP, Donner Memorial SP, Tahoe SRA, Ed Z'berg Sugar Pine Point SP, Malakoff Diggins SHP, Plumas-Eureka SP, Washoe Meadows SP, Ward Creek Unit, Burton Creek SP.** All lands, facilities, roads, beaches, and trails, other than those areas designated for camping, are closed from sunset to sunrise daily.
2. **Kings Beach State Recreation Area.** All lands, facilities and beaches are closed from 10:00 p.m. – 6:00 a.m.
3. **Grover Hot Springs SP.** The Grover Hot Springs SP day use area is closed from 10pm-8am. This includes the area of Grover Hot Springs SP west of the main campground road and south of Hot Springs Creek to the west and south boundaries respectively. Also included, but not limited to the Hot Springs Pool and complex, adjacent day use area and access road. The access road is also closed to all vehicular traffic during these hours, excluding administrative and emergency services.
4. **Empire Mine SHP.** All lands, facilities, and parking areas of Empire Mine SHP are closed from sunset to sunrise throughout the year. Additionally, the buildings and historic grounds (graveled mine yard, Bourn Cottage, and irrigated/landscaped grounds) are closed from 5pm-10am daily, plus Thanksgiving Day, Christmas Day, and New Year's Day.
5. **Bodie SHP.** All lands and facilities of Bodie SHP are closed from 5pm-9am from the Saturday before Memorial Day through Labor Day; the remainder of the year the park will be closed to public entry, use or occupancy from 3pm to 10am. -or as otherwise posted. Through traffic may proceed on the designated route through the park at all times.
6. **South Yuba River SP.** The parking lot at the Old Highway 49 Bridge is closed to parking from 10pm to 3am daily. All lands of the Bridgeport Unit, located north and west of Pleasant Valley Road, and the parking area at Jones Bar, are closed from sunset to sunrise daily.

The District Superintendent, or his/her designee, may grant exemptions to this order as determined to be necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees and resources. All exemptions, except for emergency personnel, must be obtained in writing. Requests for exemptions may be made by contacting the District Superintendent, Sierra District, 7360 West Lake Blvd., Tahoe, California 96142.

Nothing herein shall be construed in derogation of other provisions of law, existing contracts or property rights previously granted.
