THIS ORDER SUPERSEDES ORDER NO. 690-017-2024

Hours of Operation

The lands and facilities of Folsom Lake State Recreation Area are hereby closed to public use, entry, occupancy or parking of vehicles except as provided below. Daily closing hours are posted at major public use areas and at entry gates. Outbound gates at day use areas are locked at the posted closing hour. Inbound gates may be closed thirty (30) earlier.

DAY USE HOURS

Regular day use hours for Beal's Point, Folsom Point, Granite Bay, Black Miners Bar and Peninsula are:

Winter months – End of Daylight-Saving Time, 7:00 a.m. to 7:00 p.m.

Summer months – Beginning of Daylight-Saving Time, 6:00 a.m. to 9:00 p.m.

Regular day use hours for Folsom Powerhouse SHP, Parkshore, Nimbus Flat, Nimbus Overlook, Nimbus Shoals, Willow Creek and Folsom Sector Office Parking Lot are:

Winter months – End of Daylight-Saving Time, 7:00 a.m. to 7:00 p.m.

Summer months – Beginning of Daylight-Saving Time, 6:00 a.m. to 9:00 p.m.

Regular day use hours for Rattlesnake Bar, Mormon Island, Mormon Island Wetlands, Salmon Falls Raft Take-out, Skunk Hollow, Darrington Bike Lot and Old Salmon Falls are:

Winter months – End of Day Light Saving Time, 7:00 a.m. to 6:00 p.m.

Summer months – Beginning of Daylight-Saving Time, 7:00 a.m. to 9:00 p.m.

Regular day use hours apply to all areas except the following:

- a. Campgrounds
- b. Overnight moorings for registered boat campers
- c. Folsom Lake Marina at Brown's Ravine

SPECIAL USE HOURS

Brown's Ravine/Folsom Lake Marina

Winter months - End Daylight Saving Time, 7:00 a.m. to 7:00 p.m.

Summer months - Beginning Daylight-Saving Time, 6:00 a.m. to 10 p.m.

During low water conditions, when not all marina facilities are usable, the operating hours may be modified as needed by the marina manager. Such modifications shall be posted at the entrance.


Exception to this order may only be granted in writing by the Gold Fields District Superintendent at 7806 Folsom-Auburn Road, Folsom, CA 95630.


