THIS ORDER SUPERSEDES ORDER NO. 690-009-2024

Orangevale Bluff Closure

The area of Folsom Lake State Recreation Area commonly known as the Orangevale Bluffs is closed to all public entry. This closure is in effect for the safety of the visiting public both on and below the unstable bluffs.

The prohibited area is defined below and as depicted on the attached map:

- A) On the east five feet from the existing American River Bike Path (Jedediah Smith memorial Trail – paved)
- B) On the west at the existing fence line along the top of the bluff. If a fence is not present, then the Pioneer Express Trail shall dictate the boundary.
- C) On the north, at the intersection of the Pioneer Express Trail and the American River Bike Trail at the west end of the Black Miners Bar Unit.
- D) On the South at the intersection of the pioneer express trail and the American River Bike Trail north of mile marker 26.

Exceptions to this order may only be granted in writing by the Gold Fields District Superintendent at 7806 Folsom-Auburn Road, Folsom, CA 95630.

Nothing herein shall be construed in derogation of other provisions of law.
