ORDER NO. 690 - 019 • 2025

April 10, 2025

THIS ORDER SUPERSEDES ORDER NO. 690-011-2025

Water Safety

1. No person shall operate any motorized craft in excess of five (5) miles per hour on Folsom Lake, as follows:
 - a. Within 200 feet of any shore, boat launching facility, or designated mooring area.
 - b. In posted areas, or areas designated by marked buoys.
 - c. In areas not defined herein which are subject to regulation by the Harbors and Navigation Code.
 - d. Radio- or remote-controlled model boats shall not operate at over 5 MPH within 50 feet of any swimmer, bather, designated swim area, dock, or boat launch facility (model boats may be operated at greater than 5 MPH in other areas within 200 feet of shore).
2. Vessel operation on Lake Natoma:
 - a. As of April 14, 2025, all trailered or motorized vessels shall not be permitted for launch or operation on Lake Natoma.
 - b. Other non-trailered crafts powered by electric trolling motors shall not be operated in excess of five (5) MPH. (Includes radio- or remote-controlled model boats, and kayaks powered by electric trolling motors.)

Exceptions:


- Employees, officers, contractors, and permittees of the California Department of Parks and Recreation and U.S. Bureau of Reclamation entering the area on official business.
3. All areas of Folsom Lake State Recreation Area are open to bathing, as defined in Harbors and Navigation Code section 651.1, except the following:
 - a. The docks, floats, breakwater, and mooring areas of Folsom Lake Marina at Brown's Ravine.
 - b. The buoyed areas at Folsom Dam, Nimbus Dams, and the Folsom South Canal.

- c. Areas immediately adjacent to, in front of, and 500 feet out from all launch ramps.
 - d. Nimbus Shoals, between the Hazel Avenue Bridge and Nimbus Dam.
 - e. Other specifically identified areas may be posted.
4. Inflatable device may be towed behind motorized craft in the Folsom Lake "open zone" only under the following conditions:
- a. The device must be designed and manufactured for towing.
 - b. The towrope shall be no longer than 75 feet.
5. Skim boarding is prohibited on all designated swim beaches, and within 50 feet of any swimmer, bather or pedestrian within Folsom Lake State Recreation Area.
6. Parasailing is prohibited on Folsom Lake
7. Boat launching is prohibited at all times in the area known as Nimbus Shoals on the America River between the Hazel Avenue Bridge and Nimbus Dam.
8. All areas of Folsom Lake State Recreation Area are open to fishing, except for the following:
- a. The shoreline of Folsom Lake Marina basin, beginning 50 feet west of the boat sanitation station, and extending around the marina basin to 50 feet beyond the last stairway and dock at the southeast end, as posted.
 - b. Within 50 feet of any portion of the designated launch ramps, including the low water ramps.
 - c. All courtesy docks, fuels docks, marina docks and floating restrooms.
9. Parking is prohibited on all Folsom Lake State Recreation Area launch ramps. Ramps are for the immediate launching and de-launching of vessels.

Exception to this order may only be granted in writing by the Gold Fields District Superintendent at 7806 Folsom-Auburn Road, Folsom, CA 95630.

Nothing herein shall be construed in derogation of other provisions of the law.


