# Henry W. Coe State Park PARK CLOSED due to the SCU LIGHTNING COMPLEX FIRE

1. Effective August 31, 2020, and as a result of the SCU Lightning Complex Fire that started on August 16, 2020, all lands, trails, and buildings are hereby closed to the public for public safety and to direct appropriate resources to facilitate Post Fire Rehabilitation. All lands and roads of the park will be closed until further notice to all recreational uses as indicated by "CLOSED AREA" on the Closure Map attached. Every effort will be made to post all entrances and access points to the areas to notify the public. As park lands are deemed safe and ok to enter, this closure will be modified to allow use in safe areas.

#### 2. EXCEPTIONS:

- a. Employees of California State Parks, authorized volunteers, and any contractors employed by the Department.
- b. Emergency Personnel (i.e.: CALFIRE, CHP, Sheriff, etc.)
- c. Utility workers doing work as authorized by the District Superintendent or their designee.
- d. Inholdings and ranchers with easement access to their property.
- 3. This is a temporary closure that will allow the Department to rehabilitate the burned areas without further impacting the natural, historical and cultural resources in the critically affected burned areas. All efforts will be made to open up areas as resource protection and recovery is completed and public safety can be ensured.
- 4. Nothing herein shall affect any existing concession contract, private contract or property rights.
- 5. Exceptions to this order may only be granted in writing by the Diablo Range District Superintendent, 15751 Tesla Road, Livermore, California 94550.
- 6. Nothing herein shall be construed in derogation of other provisions of law.
