In accordance with provisions of California Code of Regulations, Title 14, Section 4326, for the protection of the health and safety of persons, property, and resources of the lands and facilities of Anza-Borrego Desert State Park are hereby closed to public use, entry, and occupancy except as provided below. Day Use hours are posted at entrances to public use areas and entry gates.

1. Regular day use hours for Anza-Borrego Desert Park Visitor Center Parking Lot are:

Gates will be open daily to the public from 7 AM to 7 PM from October 1 to May 31 annually.

Gates will be closed Monday thru Friday, and open from 7 AM to 7 PM on Saturday, Sundays, and holidays from June 1 to September 30 annually.

2. Regular day use hours for the Borrego Palm Canyon Trail and Borrego Palm Canyon Trailhead Parking Lot are:

Sunrise to Sunset: Seven (7) days a week, year round.

3. Regular day use hours for the Hellhole Canyon Trail and the Hellhole Canyon Parking Lot are:

Sunrise to Sunset: Seven (7) days a week, year round.

4. Exceptions to this order may only be granted in writing by the District Superintendent, Colorado Desert District, 200 Palm Canyon Drive, Borrego Springs CA 92004-5005.

5. Nothing herein shall affect any existing private contracts or property rights.

6. Nothing herein shall be construed in derogation of other provisions by law.



 - E. Lucky 5 Trails from Sunrise Parking Lot on San Diego County Road S-1.
 - F. Pacific Crest Trail.
 - G. Designated trails within Hawi-Vallecito Cultural Preserve.

Primitive Camping

DISTRICT SUPERINTENDENT'S ORDER NUMBER:

940-005-14

1. Primitive camping (as defined in California Code of Regulations (CCR), Title XIV, 4451) is allowed in the backcountry areas of Anza-Borrego Desert State Park® under the following conditions:
 - A. In the park's eight (8) designated primitive camps as listed on the park map (Arroyo Salado, Blair Valley, Culp valley, Fish Creek, Mountain Palm Springs, Sheep Canyon, Yaqui Pass, and Yaqui Well.)
 - B. Along the park's designated dirt roads where vehicles must be parked no more than one (1) car length off a given road where it will not disturb natural features.
 - C. In road less areas where a camper may travel on foot.
2. In all cases, campfires must be kept inside a camp stove or in a metal container provided by the camper with a bottom and sides.
3. Firewood shall also be brought in with a camper and may not be collected in the park.
4. Ashes must be carried out along with trash and other debris.
5. All natural and cultural features are protected. Nothing may be removed or disturbed, including plants and rocks.
6. As such, the entire backcountry area of Anza-Borrego Desert State Park® is defined as a camping facility. Per CCR Title XIV, 4455, occupancy by the same persons, equipment, or vehicles of any camping facility within Anza-Borrego Desert State Park is limited to a total of thirty (30) days in any calendar year.

7. Primitive camping is **NOT** allowed in the vicinity of the Borrego Palm Canyon Campground developed area bounded by Hoberg Road to the east, Palm Canyon Drive from Hoberg Road west, to the bottom of San Ysidro Peak behind the Visitor Center, following along the bottom of San Ysidro Peak north to the first Palm Grove in Borrego Palm Canyon, and the following from Palm Canyon along the bottom of Indian Head Mountain east to Hoberg Road. Nor is primitive camping allowed in areas posted with "No Camping" signs.
8. Exceptions to this order may only be granted in writing by the District Superintendent, Colorado Desert District, 200 Palm Canyon Drive, Borrego Springs, CA 92004-5005.
9. Nothing herein shall affect any existing private contracts or property rights.
10. Nothing herein shall be construed in derogation of other provisions by law.

Unmanned Aircraft

1. No person shall launch, land, or operate a powered unmanned aircraft or Unmanned Aerial System (UAS) within Anza-Borrego Desert State Park®, Cuyamaca Rancho State Park, and Palomar Mountain State Park. Exceptions to this directive may include the following:
 - A. Commercial filming with the proper permitting for the use of a UAS or other aircraft.
 - B. Use by law enforcement under exigent circumstances with direct permission of the District Superintendent.
 - C. Scientific research conducted with direct permission of the District Superintendent.
 - D. Other uses exempted by the District Superintendent by application.
