ORDER NO. 555-24-07

1. To ensure the health and safety of persons and property on lands administered by the Department of Parks and Recreation, Desert Division; Ocotillo Wells SVRA, Salton Sea SRA, Indio Hills Palms Property, Picacho SRA, and Heber Dunes SVRA, for the safety and welfare of the public, the following restrictions are in effect:
  - A. No person shall import or export any litter, domestic, agricultural, or commercial garbage or refuse, for the express purpose of disposing of such material in the State Park trash cans or dumpsters.
  - B. No person shall climb on or into trash containers, dumpsters, nor remove, separate, or dislodge the contents inside in total or in part.
  - C. No person shall place petroleum waste products, batteries or toxic substances in trash containers and/or dumpsters.
  - D. No person shall place ignited or smoldering materials or coals inside any trash containers and/or dumpsters.
2. Exceptions to this order may be granted in writing by the District Superintendent, Ocotillo Wells District, 5172 Hwy 78 #10, Borrego Springs, CA 92004.
3. Nothing herein shall affect any existing private contract or property rights.
4. Nothing herein shall be construed in derogation of other provisions of law.
