**Bow Fishing
Lake Perris State Recreation Area**

DISTRICT SUPERINTENDENTS ORDER NO. 952-21-001
Supersedes Order 952-19-001

Whereas: Anyone that is participating in bow and arrow fishing at Lake Perris State Recreation area must have a valid State of California fishing license and shall abide by California Code of Regulation Title 14 and State Fish and Game Code Regulations.

1. The following lands, waters, and facilities of Lake Perris State Recreation Area are hereby permitted for public use as it pertains to bow fishing:
 - A. Bow and arrow fishing tackle must have the arrow's shaft or the point, or both securely attached by a line to the bow or to a fishing reel (includes crossbows). Arrows must have a tip designed for bow and arrow fishing, the use of broad heads is prohibited.
 - B. Bowfishing is not allowed from shore. Bowfishing is only authorized from a vessel in designated areas of the lake. The established area is inside the 5 MPH zone from east of Power Cove launch ramp to the western end of Bernasconi Day Use Area where the outlet buoy line is established. (See Map). No other area of the lake is permitted. Bowfishing is not allowed in the open zone of the lake outside of the 5 MPH zone.
 - C. Bow and arrow and crossbow fishing gear are considered weapons within the State Park system. When not actively bow fishing, the bow and arrow and crossbow fishing gear must be stored on the vessel at all times. It is acceptable upon arrival to transfer the equipment from a vehicle to the vessel and from a vessel to a vehicle at the conclusion of the day.
 - D. All fish taken by bow and arrow SHALL be removed from Lake Perris State Recreation Area in a manner consistent with CCR Title 14 1.87 – Waste of fish. Pursuant to this law, no fish may be wasted or disposed in any trash receptacle or disposed into the lake.

- E. Bowfishing is prohibited within 100 feet of any person or vessel outside the vessel of the bow and arrow hunter.
 - F. No person shall harvest, attempt to harvest and/or possess any game fish with the exception of Carp from Lake Perris taken via method of bow and arrow fishing.
2. The District Superintendent, or designee, may grant exemptions to this order as determined necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees, wildlife and resources. All Exemptions, except for emergency personnel, must be obtained in writing. Requests for exemptions may be made by contacting the District Superintendent, Inland Empire District, 17801 Lake Perris Dr., Perris, California 92571.



1. The lands, waters and facilities of Lake Perris SRA are hereby restricted in the following manner:
 - A. The maximum allowable boat speed limit on Lake Perris SRA is 35 miles per hour.
 - B. All boat and vessel traffic outside of the buoyed 5 MPH areas shall move in a counter clockwise direction of travel around Alessandro Island while on Lake Perris SRA. This traffic pattern increases nautical safety and is required due to the size of the lake and the amount of traffic. The exemption to this order is:
 - 1) When a vessel towing a skier / tuber needs to turn around to pick up a skier / tuber that has fallen
 - 2) All other situations including 360/180 trick / freestyle maneuvers are prohibited
 - C. Five miles per hour (wakeless forward motion) is the maximum allowable speed in the following circumstances:
 - 1) Within all areas marked with 5 mph or wake less speed regulatory buoys between shoreline and buoy line.
 - 2) Before sunrise or after sunset
 - 3) During restricted visibility (visibility less than 1000 feet due to fog, haze, smoke etc.)

- D. No person shall launch a vessel when the lake boating capacity is reached for existing water elevation and capacity as determined by Park Officials.
 - E. No vessel shall operate, anchor, or launch when the following conditions exist:
 - 1. No personal watercraft, powerboat, kayak, or float tube with less than 6 inches of freeboard, measured from the water surface to the lowest portion of the gunwale, shall operate, anchor, launch or remain on the lake's surface when wind speed reaches or exceeds 25 miles per hour (Inland Lake Wind Advisory).
 - 2. The lake surface will be closed to all vessels or similar objects when a wind speed of 39 miles per hour or greater is reached (Gale).
 - 3. Appropriate wind warning systems (In accordance with U.S. National Weather Service) shall be posted during conditions noted in sections F(2) and F(3) above.
 - F. No vessels shall enter the posted buoyed swimming areas at any time.
 - G. Vessels may only moor to a launch ramp courtesy dock for a period of 15 minutes to launch or retrieve a vessel. Vessels may not moor on the shore within 15 yards of any launch ramp.
 - H. Submersible vessels are not permitted.
 - I. No person shall launch, allow to enter, moor, or beach a power-driven vessel in the area known as Sail Cove. The boundaries and limits of this area are:
 - a. Eastern limit extends to Point 1, west of Perris swim beach
 - b. Western limit extends to Perris Dam
 - c. Southern limit extends to a line of control marked navigation aids with markings "No Power Vessels"
 - J. Any floating device, as defined in CCR T14 4652, used in an open zone in Lake Perris SRA must have a United States Coast Guard approved personal floatation device for each person on board.
 - K. All vessels, whether motorized or non-motorized, must pass a Dreissenid Mussel (Quagga and Zebra) inspection before launching.
2. The District Superintendent, or designee, may grant exemptions to this order as determined necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees, wildlife and resources. All Exemptions, except for emergency personnel, must be obtained in writing. Requests for exemptions may be made by contacting the

Other Power Driven Mobility Device (OPDMD) Policy
Lake Perris SRA

In order to ensure public safety and minimize adverse resource impacts, OPDMD's may only be operated within Lake Perris State Recreation Area by individuals with mobility disabilities and in accordance with the following criteria.

1. Evidence of Mobility Disability

Unless otherwise authorized, the use of OPDMD's in Lake Perris State Recreation area is restricted to people with mobility disabilities as defined in §35.104 of Title II of the American with Disabilities Act. All users of OPDMD's must provide credible assurance that the mobility device is required because of their disability. Credible assurance may be provided by showing a National Parks and Federal Recreational Lands Access Pass or proof of assignment of any State's valid disabled parking placard or card assigned to the person who will be using the OPDMD. If a person does not have a state issued placard or card, employees must accept as a credible assurance a verbal representation, not contradicted by observable fact, that the OPDMD is being used for mobility disability.

2. Types of OPDMD

- a. **Size:** OPDMD shall not be wider than 36" or longer than 48"
- b. **Weight:** The overall weight of the device and user(s) shall not exceed 550 pounds
- c. **Speed:** OPDMD shall not be operated at speeds in excess of 5 miles per hour
- d. **Noise:** OPDMD shall not produce noise levels in excess of 70 decibels
- e. **Emissions:** OPDMD shall not exceed zero emissions during use.

3. Areas of Authorized Use


OPDMD's that meet the above criteria are allowed in the following locations at Lake Perris SRA:

All roads/trails where mountain bikes are currently permitted to travel (including the following):

Paved bike paths, day use areas, Sail Cove shoreline, dam, fishing piers, parking lots, sidewalks, marina paths and docks, campgrounds, picnic areas, playgrounds, horse trails, launch ramps, and upland game hunting areas.

OPDMD may not access the Teri Peak trail because of public safety issues. This trail has difficult slopes, uneven terrain, and narrow widths in certain sections.

4. The use of OPDMD's is prohibited unless they meet the above criteria for type of device, are being operated by persons with mobility disabilities on the above-described locations.
5. The District Superintendent, or designee, may grant exemptions to this order as determined necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees, wildlife and resources. All Exemptions, except for emergency personnel, must be obtained in writing. 1. Fishing at Lake Perris SRA is prohibited in the following areas:
 - a. Any designated swim area.
 - b. From a vessel within the area designated as the marina, except a vessel which is secured in a slip, currently leased to the owner/operator of the vessel.
 - c. From the areas on the shore in the marina area immediately below the marina general store and its facilities.
 - d. From the launch ramp docks or any vessel secured or moored to the courtesy dock, when the launch ramp is open for boater use.
 - e. From the Law Enforcement Patrol dock near lifeguard headquarters and from shore within 10 yards of both sides of the patrol dock.
 - f. Inside of the no trespassing / restricted area buoy line of the Lake Perris Outlet tower. (Casting over the line is ok). Fishing while trespassing is prohibited.
 - g. The above areas are properly posted.
2. The District Superintendent, or designee, may grant exemptions to this order as determined necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees, wildlife and resources. All Exemptions, except for emergency personnel, must be obtained in writing. 

1. Swimming (excluding water skiing and boating related activity) is restricted to the posted swim areas at Perris and Moreno beaches.
2. No person shall swim in areas prohibited for swimming. Such swimming areas shall be designated by the posting of notices. (CCR Title 14 4650)
3. The District Superintendent, or designee, may grant exemptions to this order as determined necessary for the proper administration of the park, and to protect the safety and welfare of its visitors, employees, wildlife and resources. All Exemptions, except for emergency personnel, must be obtained in writing. 
