California Off-Highway Motor Vehicle Recreation Commission Set To Meet, Allocate Funds January 10, 11 in Southern California

The California Off-Highway Motor Vehicle Recreation Commission will meet in Southern California January 10 and 11 where it will allocate off-highway vehicle funds for local and federal Southern California summer grants for the 2001/ 2002 fiscal year.

The meeting will be held at the Hilton Hotel-Ontario Airport, 700 N. Haven Avenue, Ontario. The meeting is scheduled to begin at 9 a.m. both days.

The State provides grants to local agencies and enters into cooperative agreements with federal agencies to provide managed OHV recreation in California. Since 1986, the Off-Highway Motor Vehicle Recreation Division of California State Parks has awarded \$194 million through grants and cooperative agreements for conservation, law enforcement, land acquisition, development, and operation of local and federal OHV areas.

The Commission was created by the Legislature in 1982 to allow public input and provide policy guidance for the OHV program. The Commission's duties include: allocating funds for OHV capital outlay expenditures and OHV grants and cooperative agreements; certifying environmental impact reports; and considering adverse impacts on property in the vicinity of State Vehicular Recreation Areas, and recommending measures to the Division to reduce those impacts.

Seven Commissioners are appointed to staggered, four-year terms. The Governor appoints three of the members, and the Senate Rules Committee and the Speaker of the Assembly each appoint two. The Commission membership is required to represent a broad range of disciplines relevant to off-highway recreation -- OHV recreation enthusiasts, biologists, rural landowners, soil scientists, and environmental interests.
