## SUMMARY AND ANALYSIS

The purpose of this statistical report is to provide selected data sets which portray the fundamental measures of California State Parks for the 2021/22 fiscal year. Collectively, this data shows the scope and scale of the State Park System, its activities and operations, and offers implications as to the benefits derived by its users..

The ability to compare data through time will be limited due to the lack of detailed statistical information from the eleven years 1990/01 through 2000/01, during which time statistical reports were not prepared.

This report's summary and analysis is limited to the system-wide totals of the various data sets.

Number of Units and Properties - The total figure of basic classified units and major unclassified properties is 280. There were no units added or subtracted from the State Park System in FY 2021/22.

Acreage, DPR-Owned - The total of 1,377,329.23 acres reflect an increase of approximately 1.405% (19,087.8669 acres) over the previous published fiscal year report (FY 2018-19).

Acreage, Other - The total of 273,168.94 acres show a decrease of approximately 7.21% (21,255.3272 acres) from the previous published fiscal year report (FY 2018-19).

Total Acreage - The State Park System's total acreage, a data category not reported in the table, is the total of the two previous figures. At 1,650,498.17 acres, this total reflects a decrease of approximately 0.131% (2,167.46 acres) from the previous published fiscal year report (FY 2018-19).

**Waterfront Feet** - The total of the four categories of waterfront footage is 8,878,918.23 (the equivalent of 1,681.61 miles), a 0.375% (33,205.23 linear feet (6.29 miles)) increase over the previous published fiscal year (FY2018-19). The waterfront length related to the shoreline of lakes and reservoirs is 3,492,159 linear feet (or 661.39 miles), a 0.94% (32,667 linear feet (6.19 miles)) increase over the previous published fiscal year (FY2018-19). The length of frontage on the Pacific Ocean and its major bays and estuaries is 1,816,895 linear feet (the equivalent of 344.11 miles), a 0.55% (9,910 linear feet (1.88 miles)) increase over the previous published fiscal year (FY2018-19). The length of river footage is 1,749,254.23 linear feet (the equivalent of 331.3 miles), a 0.53% (9,372 linear feet (1.775 miles)) decrease over the previous published fiscal year (FY2018-19). The length of submerged footage remained the same at 1,820,610 linear feet (the equivalent of 344.81 miles).

All waterfront feet reported reflect actual footage that is owned or managed by California State Parks. Some units within the system include waterfront footage that is operated by entities outside California State Parks. Furthermore, the reporting of waterfront can be misleading. These data are literal in that while a coastline would have one area of separation between water and land a river would have two, one for each bank of the river. If California State Parks owns or manages both sides of the river (such as a river that runs through parkland) then, for example, a 50-foot section of river would include 100 feet of waterfront feet. Rivers are natural features and therefore each bank of the river would include different waterfront footage data depending on factors such as river width, erosion, topography, etc.

Individual Camp Sites - A total of 13,426 individual sites in the 2021/22 fiscal year. This data reflects a decrease of 732 individual camps sites since the previous published fiscal year (FY2018-19), a difference of 5.17%.

Note: Because of the way individual camp sites (sometimes labeled as “family camp sites”) have been variously defined and counted over the last three decades, this figure cannot be usefully compared with any “information” earlier than fiscal year 2001/02. Over the last twenty years, estimates have run as high as 17,772 sites.

Group Camp Sites - A total of 313 such sites existed in the State Park System in the 2021/22 fiscal year. These data reflect a decrease of 3 group campsites from the previous published year (FY2018-19), a difference of 0.95%.

Non-Camping Overnight Facilities - There were 725 such facilities existing in the State Park System. The number of non-camping overnight facilities increased by 13 sites (1.83%) from FY2018-19. These facilities were a range of accommodations, which include rooms in commercial lodging, cabins, and the use of space in hostels.

Individual Picnic Sites - A total of 5,927 such facilities existed in the State Park System. This reflects a 19.99% decrease (1,481 sites) in individual picnic sites from the previous year.

Group Picnic Sites - A total of 275 facilities existed in the System. This reflects a 2.91% increase (7 sites) in group picnic sites from FY2018-19.

Non-Motorized Trail Miles - A total of 4,864.60 miles existed in the System. This is a 6.64% decrease of 346.18 miles more than that reported in FY2018-19.

Motorized Trail Miles – A total of 1,186.09 miles existed in the System. These data reflect a decrease of 43.5 miles from FY2018-19, a difference of 3.54%.

Visitor Attendance – Day Use - The total of 85,315,307 day use visitors included both those who paid an admission fee and those who were admitted free. Almost three quarters (69.55%) of all day use visits are unpaid or free. This total figure reflected an increase of 14.49% over the previous published report (2018/19 fiscal year). Since the tabulation of visitor attendance includes many variables such as but not limited to methodology of collection and economic factors, any explanation of this increase would be speculative.

Visitor Attendance – Camping - This figure reached a total of 7,773,133 overnight uses, an increase of 17.86% over the previous published report (2018/19 fiscal year). Note that the camping attendance contains only some of the overnight use of the system that takes place in structures, as explained in Appendix B. This situation makes it impossible to make a valid correlation between the total of overnight public use facilities and overnight visitor attendance.

Visitor Attendance – Total - This figure reached 93,088,440 an increase of 14.77% over the previous published report (2018/19 fiscal year).

Revenue - User Fees - The total of \$117,099,870.90 reflects a 11.49% decrease from the previous published report (2018-19 fiscal year).

Revenue – Concessions - The total of \$20,414,354.93 reflects a 13.79% decrease from the previous published report (2018-19 fiscal year).

Revenue – Miscellaneous - The total of \$1,257,720.08 reflects an decrease of 91.91% from the previous published report (2018-19 fiscal year). Historically, the Department's reporting of miscellaneous revenue has fluctuated dramatically due to ever changing sources of revenue.

Total Revenue - The System's total revenue of \$137,771,945.91, the sum of the above three categories, reflects a decrease of 19.67% from the previous published report (2018-19 fiscal year). The three revenue categories listed above, based on California State Parks' "earnings", constitute an important part of the State Park and Recreation Fund (SPRF).

Occasionally, districts will report a negative revenue figure. This does not necessarily mean that the district has lost revenue but is more likely a carryover debit from the previous year or a cost associated with an individual unit reported at the district level.

Operating Costs: The total expenditures for field operations were a total of \$462,641,858, a 27.50% increase from the previous published report (2018-19 fiscal year).

Prior to the 2013/14 fiscal year, operating costs were reported at the district and sector level. Since revenue has historically been reported at the unit level, the comparison of operating costs to revenue has been impossible at the unit level. Now that operating costs are reported at the unit level, this comparison provides useful data previously unavailable.

Authorized Permanent Full-Time Positions - The total of 1,822.1 positions for the 2021/22 fiscal year reflected an increase of 22.24% (331.5 positions) from the previous published report (2018-19 fiscal year).

Authorized Temporary Positions (ATP) - In terms of person-year (PY) equivalents, a total of 1,416.5 1,539.4 positions reflected an increase of 8.68% (122.9 positions) over the previous fiscal year. Comparing the authorized permanent full-time positions to the ATP indicates a trend to convert permanent positions to temporary.
