PROJECT TITLE: General Creek Ehrman BBQ 2017 Flood Repairs

LOCATION: Ed Z'berg Sugar Pine Point State Park COUNTY: El Dorado

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Stabilize and repair the area around the Ehrman BBQ, at Ed Z'berg Sugar Pine Point State Park to repair damage caused by a 2017 flood event and to protect the resource from potential damage from future flood events. Work will:

- Use an excavator and hand crew to pack a total of 100 yards of material (10 yds. of small boulders, 70 yds. of cobble, and 20 yds. of gravel) into the undercut (gully) created beneath the BBQ;
- Place a line of 2' -3' boulders along the toe of the bank in front of the BBQ;
- Place 3 - 4, 2'-3' boulders by the edge of the concrete abutment of the bridge;
- Fill the 12' x 11' x 5' deep scour hole with 6" - 12" cobble mixed with 15 - 25% gravel that is <3" in size;
- Compact the fill to match the existing ground elevation of the pedestrian path and area adjacent to the BBQ;
- Slope the grade approx. 45 degrees toward a channel that ties into General Creek both on the adjacent upstream bank on the upstream side and at the bridge abutment on the downstream side; and
- Insert the willow stakes into the fill at ~3' on center with ~6" exposed above the fill.
